Laying of Optical Fiber along existing NEC Road on side berm by Horizontal Directional Drilling (HDD) method in Holaidanga and Paham area of West Garo Hills District, Meghalaya State

M/S Reliance Jio Infocomm Ltd., (formerly known as Infotel Broadband Services Ltd.) having its registered office at 9th Floor, Maker Chambers IV, 222, Nariman Point, Mumbai - 400021 has been issued Unified Licenses ("UL") under section 4 of the Indian Telegraph Act, 1885 on 21.10.2013 by the Department of Telecommunications, Government of India, for all service areas in India to establish, operate and maintain telecommunication networks and telecommunication services and is engaged in the business of providing broadband internet services and other allied services on panIndia basis. Previously Infotel Broadband Services Ltd. (now name changed to Reliance Jio Infocomm Ltd.) was registered with Department of Telecommunications (DOT) as infrastructure provider category I (IP-I) vide registration certificate no.: 370/2011 dated 23rd June 2011 to establish and maintain the assets such as Dark Fibres, Right of Way, Duct Space and Tower

As such, to set up our network in different parts of Meghalaya, we have been laying Optical Fibre Cable in different routes and one such road is Tikrikila-Singhimari road where at present we are undertaking our work.

In the area Holaidanga and Paham, This Road is transiting through Forest area and we have been asked by the Forest Department to seek Forest Clearance in this regard.

The Project is of Laying of Optical Fiber Cable inside HDPE ducts of 40 mm Dia by *HDD Method (Horizontal Directional Drilling)* a Pit of Size 1mtrX1mtr X1.2 mtr Depth at an interval of 100 mtrs along the route.(Diagram Attached)

This boring will be done along the Road side Berm of PWD NEC Road. Necessary Permission from State PWD dept has already been obtained.

As no other Utility corridor exists in this zone except the Road, this Operation has to be executed along the Roadside which is passing through a forest area. We require permission from the forest authority in this regard.
