The Executive Engineer, T.R.T.S., Division, Vizianagaram It is requested to go through the conditions imposed by the Government of India and Prl. Chief Conservator of Forests, A.P., Guntur carefully and furnish the condition wise compliance report to this office at the earliest.

The user agency is requested to pay the following amounts towards Net present value and compensatory afforestation through e-payment portal.

- A) Net present value = Rs. 27.69 lakhs.
B) Compensatory afforestation = Rs. 18.19 lakhs.

The procedure for e-payments is through on line portal as prescribed by MoEF&CC, New Delhi, vide letter dated: 23.09.2015 i.e., challan generated through the Ministry's website portal (i.e., www.forestclearance.nic.in) in Adhoc-CAMPA, as per the guidelines issued by the Ad-hoc CAMPAs, New Delhi letter dated: 09.06.2016 communicated vide this office letter Rc.No.45921/2001/FCA-4(i), dt: 05.07.2016.

It is also requested to comply the following conditions in accordance with the Government of India instructions issued vide F.No.7-23/2012/FC, dt: 24.07.2013 communicated vide PCCF's Rc.No.45921/2001-F4, dt: 23.08.2013 and publish the orders at the cost of the project proponent.

- 1) Publish the entire Forest clearances granted in verbatim along with the conditions and safe-guards imposed by the Central Government in two widely circulated daily news papers, once in vernacular language and the other in

English language, so as to make people aware of the permission granted to the project proponent for use of forest land for non-forest purposes.

- 2) The copies of the forest clearance should also be submitted to the Heads of local bodies, Panchayats and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same in 30 days.

Please note that the transfer of forest land to user agency shall not be effected prior to the issue of Final approval.
