



The following points have been discussed in the meeting regard to for diversion of forest land in SPSR Nellore Division passing through Compartment No.71 Donthali Reserve Forest in Nellore Rural Mandal


1. The Executive Engineer, P.R, P.I.U Division, Nellore has applied for "Formation of inspection path along Thikkavarappadu branch canal" in SPSR Nellore Division passing through Compartment No.71 Donthali Reserve Forest in Nellore Rural Mandal for proposed diversion of 0.95Ha. and Grama Sabha conducted in Donthali Panchayat under the chairmanship of Special Officer of Donthali. As discussed in Grama Sabha and the Grama Sabha Came to conclusion that **No area** is under cultivation of Schedule Tribes or Schedule Community and also **No Community Rights** were given to the villagers.

2. In accordance with the Recognition of Forest Rights Act-2006, The Grama Sabha has discussed in detailed and had to a conclusion that there were **No individual claims or community claims in the said area**. Hence the approval may be granted to the user agency.

3. The Grama Sabha have certified that all formalities / processes under the FRA have been carried out and the copy of the resolutions passed by the Grama Sabha are here with enclosed.
