With reference to the subject cited above, our proposal for diversion of 0.95 ha of forest land is with your good office seeking prior approval of Central Government under Section-2 of Forests (Conservation) Act, 1980. On scrutiny of the proposal, Conservator of Forests (Central) vide letter No: -ORC327/2017-BHU has advised us to furnish the following information:


- The user agency has informed that the route of the pipeline from the pump house will be on non-forest land on possession of Water Resources Department. The status of the land (Kisam) of the pipeline route may be submitted.
- FRA certificate need to be submitted in original or to be attested by the issuing authority as per Ministry's letter No.11-360/2016-FC dated 17.11.2016.

With reference to point (b) above, we are submitting herewith the FRA certificate duly attested by the issuing Authority (Collector, Angul) for your kind consideration.

With reference to point (a), we are in the process of collecting the status of land (Kisam) of the pipe line route and will be submitted in your good office at the earliest.

TO WHOMSOEVER IT MAY CONCERN

In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No. 11-9/98-FC (pt) dated 3<sup>rd</sup> August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes, it is certified that, **Ac.2.337** of forest land proposed to be diverted in favour of **General Manager, TTPS, Talcher for construction of intake water pump house of TTPS** in Angul District falls within jurisdiction of one village in Talcher tehsil.

It is further certified that:

- (a) the complete process for identification and settlement of rights under the FRA has been carried out for the entire **Ac.2.337** of forest land proposed for diversion. A copy of records of all consultation and meeting of the Forest Rights Committees, Gram Sabhas, Sub-Division Level Committees, and the District Level Committee are enclosed as **annexure- I to III**;
- (b) the proposal of such diversion ( with full details of the project and its Implications, in vernacular / local language) have been placed before each concerned Gram Sabha of forest-dwellers, who are eligible under the FRA;
- (c) the each of concerned Gram Sabha, has certified that all formalities / processes under the FRA have been carried out, and that they have given their consent to the proposed diversion and the compensation and ameliorative measures , if any, having understood the purpose and details of proposed diversion. A copy of certificate issued by the Gram Sabha of Bhaktipal village is enclosed as **annexure-I**;
- (d) the discussion and decisions on such proposals had taken place only when there was a quorum of minimum 50% of the members of Gram Sabha present;
- (e) the diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Gram Sabha have given their consent to it;
- (f) the rights of Primitive Tribal Groups and Pre-Agricultural Communities, where applicable have been specifically safeguarded as per section 3(1) (e) of the FRA.
