After considering the Report in consultation with the Financial Adviser the matter was placed before the Full Board in its meeting held on 26.06.2000. Vide proceedings read as 3rd, paper above, the Full Board authorized the Full Time Members and Chairman to scrutinize the DPR and take appropriate decision on giving approval/administrative sanction to the same.

Accordingly the Full Time Members and Chairman considered the proposal in the Full Time Member's meeting held on 06.07.2000 in all aspects and decided to accord administrative approval for Thottiyar Hydro Electric Project (70 MW) at a cost of Rs.131.15 crores (Rupees One Hundred and Thirty One Crores and Fifteen Lakhs only) at 1999 schedule of rates and at a project completion cost of Rs.207.04 crores (Rupees Two Hundred and Seven Crores and Four Lakhs only) at 100% debt, with a completion period of 3 years starting from 2001-2002.
- 3. The Board hereby orders accordingly. The Chief Engineer (CIELA) will take further action to get necessary clearances.
