Sir,

With reference to the subject captioned above it is informed that ONGC Tripura Asset, Agartala has to undertake exploration activities including drilling of well at the revised location **GOAN** for construction of Drill site, DSA, Waste pit & approach road leading to drill site location **GOAN** which includes diversion of Reserve Forest land measuring **6.162 Ha (15.22 acres)** is required by ONGC in place of 3.052 Ha for which earlier communication made vide letter dated:29/06/2020.

As per latest guidelines communicated vide letter F.No.11-9/98-FC(pt.) Dated 05/07/2013 by Ministry of Environment and Forest (MoEF), Govt. of India, the User Agency (ONGC) has to submit a Non-Encumbrance Certificate in perspective of RoFR Act, 2006 in prescribed "**FORMAT -II**" (**for projects other than linear projects**) from the concerned District Magistrate & Collector in respect of proposed forest land to be diverted for Non Forest activities.

In this connection, copy of Mouja Map & Land statement showing proposed area of Reserve Forest land to be diverted is enclosed herewith for your kind ready reference.

It is therefore requested to kindly arrange to issue a Non-Encumbrance Certificate in perspective of **RoFR Act, 2006** in "**FORMAT -II**" against (**for projects other than linear projects**) purpose only for the proposed land as indicated below enabling ONGC to obtain permission for diversion of above forest land from the MoEF & CC, Gol, Shillong and undertake the work in the larger interest of the Nation.
