In compliance of the Ministry of Environment and Forests (MoEF) Government of India's letter No.11-9/98-FC (pt) dated 3<sup>rd</sup> August 2009 where in the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (FRA, for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5th February, 2013, where in MoEF issued certain relaxation in respect of linear projects, it is certified that 28.05 hectares of forest land proposed to be diverted in favour of Executive Engineer, Small Irrigation Department, Oros for (purpose for optional forestry land of Nirukhe in forest land) in Shindhudurg district falls within jurisdiction of Nirukhe villages(s) in Kudal Tahsil.

It is further certified that :

- (a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 28.05 hectares of forest area proposed for diversion. A copy resolution of Gram Sabha and a report from Sub Divisional officer are attached as annexure 1. They shows that no such claim was as regards forest rights of Scheduled Tribes and other Traditional Forest Dwellers
- (b) There is no claim received regarding the diversion of forest land for the Facilities managed by the Government as Required under section 3(2) of FRA.
- (c) The Proposal does not involve recognized rights of Primitive Tribal Groups and Pre-agricultural communities.
