TO WHOM SO EVER IT MAY CONCERN

In Compliance of Ministry of Environment and Forest (MoEF), Government of India's Letter No. 11-9/98-FC(Pt) dated 3rd August, 2009 wherein the MoEF issued guidelines on submission of evidence for having initiated and completed the process of settlement of Rights under Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006 (FRA, for short) on the forest land proposed to be diverted for non forest purpose i.e. Underground coal Mining. It is certified that **104.095 Ha of forest land** proposed to be diverted in favour of Singareni Collieries Company Limited, Mandamarri area for "Kalyani Khani No.6 Incline (Underground Mining)" in Compartment No. 350 in Bellampalli RF, Bellampalli division fall within the jurisdiction of Sarangapalli village of Mandamarri Mandal of Mancherial District.

It is further certified that:

- a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 104.095 Ha. of forest land proposed for diversion. A copy of records of all consultation and meetings of the Forest Rights Committee, Gram Sabha, Sub-Division Level Committee and the District Level Committee are enclosed.
- b) The proposal for such diversion (with full details of the project and its implications, in vernacular/ local language) have been placed before each concerned Gram Sabha of forest-dwellers, who are eligible under the FRA;
- c) The concerned Gram Sabha, has certified that all formalities/ processes under the FRA have been carried out, and that they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any, having understood the purpose and details of proposed diversion. A copy of certificate issued by the Gram Sabha of Sarangapalli Village is enclosed.
- d) The discussion and decisions on such proposals had taken place only when there was a quorum of minimum 50% of the members of Gram Sabha present;
- e) The diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Grama Sabha have given their consent to it;
- f) The rights of Primitive Tribal Groups and Pre-Agricultural Communities, where applicable have been specifically safeguarded as per section 3(1) (e) of the FRA.



On enquiry during the Grama Sabha it was conformed that, no such RoFR patta rights are issued to any individuals under RoFR Act, 2006 in the Reserve Forest coming in the limits of the proposed diversion of 104.095 Ha. Forest Land.

Presently, the proposed diversion of 104.095 Ha. Forest Land is under the control of Forest Department.
