

**Minutes of the 55<sup>th</sup> Meeting of State level Environment Impact Assessment Authority, Jharkhand, held on 17<sup>th</sup> April, 2018.**

The 55<sup>th</sup> meeting of the State Level Environment Impact Assessment Authority (SEIAA) was convened on 17.04.2018 at the office of SEIAA, Ranchi. The meeting was chaired by Shri S.E.H. Kazmi, Chairman, SEIAA, Jharkhand. The attendance at the meeting was as follows:-

The decisions taken in the 55<sup>th</sup> SEIAA meeting are as follows -

**I. SEIAA considered the recommendations made by SEAC in its 53<sup>rd</sup> meeting held on 22<sup>nd</sup> and 23<sup>rd</sup> February, 2018.**

- a. Expansion of cement Grinding unit of M/S Nuvoco Vistas Corp Ltd (Lafarge India Ltd.) from 4.6 to 6.6 MTPA at Jojobera Cement Plant at Village- Jojobera, Raghargora, Jamshedpur, East Singhbhum.

**It was decided to grant Environmental Clearance to the above mentioned project proposal. With the conditions recommended by SEAC.**

- b. LPG Bottling Plant of M/S Hindustan Petroleum Corporation Limited at Adityapur Industrial Area, Large Sector, Village-Gamharia, P.O-Gamharia, Saraikela- Kharsawan.

**The authority examined the recommendation made by SEAC wherein SEAC has cited-**

**Quote**

**“As per govt. of India MoEF O.M No-J-11013/41/2006-IS.II (I) dated-02.12.2009, a copy of application submitted for forest clearance, has to be submitted by the PP along with his application for EC. The PP has not so far submitted the pre requisite copy of application for forest clearance along with his application for EC.”**

**Hence, it was unanimously decided to accept the above observation of SEAC and the Environmental Clearance will be issued if PP complies the direction of MoEF &CC O.M.No-J-11013/41/2006-IS.II (I) dated-02.12.2009 regarding forest clearance before the next meeting of SEIAA.**

- c. Proposed Bulk LPG Storage & Bottling Plant of M/S Bharat Petroleum Corporation Limited at Village-Maraphari & Gorabali, Chas, Bokaro.

**The authority examined the recommendation made by SEAC. It was decided unanimously to write a letter to Deputy Commissioner Bokaro in continuation of SEAC letter no-25, dated- 13.02.2018 and letter no-32, dated-19.02.2018 to clarify and provide the required /awaited report as soon as possible whether proposed area is recorded as jangal jhari or not in government record. Environmental Clearance will**



be considered after due certificate is received in this office before the next meeting of SEIAA.

II. SEIAA considered the recommendations made by SEAC in its 54<sup>th</sup> meeting held on 27<sup>th</sup> and 28<sup>rd</sup> March, 2018.


- a. Common Bio Medical Waste Treatment Facility of M/S Medicare Environmental Management Pvt. Ltd At Plot No- A-7, Phase-II, Sindri Industrial Area, Dhanbad.

The authority examined the recommendation made by SEAC and it was unanimously decided to grant of ToR to the above be mentioned project proposal along with direction/condition to provide the certificate within one month regarding status/class of land by competent authority that whether proposed area is recorded as a jangal jhari or not in government record.


The meeting concluded with vote of thanks to the Chairman.
