SUB : Request for Non-encumbrance Certificate in perspective of RoFR Act, 2006 for the Forest land falling in Trishna WLS measuring **0.20 Ha** for exploration drilling of Well at location **TIDC**

Sir,

With reference to the subject captioned above it is informed your Honour that ONGC Tripura Asset, Agartala has to undertake exploration activities including drilling of well at the location **TIDC**. For construction of Drill site & Waste pit for the location **TIDC**, diversion of Forest land falling in Trishna WLS measuring **0.20 Ha** as per the land schedule given below is required by ONGC.

As per latest guidelines communicated vide letter F.No.11-9/98-FC(pt.) Dated 05/7/2013 by Ministry of Environment and Forest (MoEF), Govt. of India, the User Agency (ONGC) has to submit a Non-encumbrance Certificate in perspective of RoFR Act, 2006 in prescribed "FORMAT-II" (Copy enclosed) from the concerned District Magistrate & Collector in respect of proposed forest land to be diverted for Non Forest activities.

In this connection the copy of the Mouja Map & Land statement showing proposed area of Reserve Forest land to be diverted is enclosed herewith for your kind ready reference.

It is therefore requested to kindly arrange to issue a Non-encumbrance Certificate in perspective of RoFR Act, 2006 in "FORMAT II" for the proposed land as indicated below enabling ONGC to obtain permission for diversion of above forest land from the MoEF, Gol and undertake the work in the larger interest of the Nation.
