Sub: TSFD – FCA – Diversion of 25.8435 Ha of forest land for laying of Railway line from Manuguru Railway Station to Bhadradri Thermal Power Station (4 x 270 MW), Manuguru, Bhadradri Kothagudem District in favour of TSGENCO– Stage-I approval issued – **Demand notice**– issued- Reg.

It is informed that, in the reference 1st cited above, the MoEF&CC, GOI has accorded in-principal Stage-I approval for diversion of 25.8435 Ha of Forest land for laying of Railway line from Manuguru Railway Station to Bhadradri Thermal Power Station (4 x 270 MW), Manuguru, Bhadradri Kothagudem District in favour of TSGENCO.

Further it is informed that, the PCCF(HoFF) vide reference 2nd cited has issued instructions to raise the Demand notice to the User Agency in consultation with the Nodal Officer FCA for payment of Compensatory Levies like cost towards raising & maintenance of compensatory Afforestation, Net Present Value (NPV), etc., in one go.

In the reference 4th cited, the Pri.Chief Conservator of Forests, TS, Hyderabad has approved the Demand submitted by this office.

The User agency is requested to deposit the Cost of CA and NPV amounts into the Adhoc CAMPA account of Telangana by generating the challan online in the ministry's portal through E-payment mode and also the cost towards Erection of pillars, extraction of Tree growth and Cost towards translocation of trees into the PD account of Manuguru.

Further, the user agency is directed to mutate and transfer the non-forest CA lands identified for the project in WLM Kinnerasni and Manuguru divisions and also to pay the compensation to RoRF claimants as per the Land Acquisition, Rehabilitation and Resettlement Act, 2013. The user agency will also be requested to approach the TSFDC and pay the compensation towards loss of plantations raised by TSFDC due to the project.
