Subject: Requirement of Special Power of Attorney with regard to Project executed from Construction Office, Patna.

The Special Power of Attorney with regard to Project executed from Construction Office, Patna was sub-delegated to Shri D Sriganesh, CGM(Construction) by ED ERPL. The following were 02 (Two) separate Special Power of Attorney:-

- 1) To sign all documents/MOUs, Agreements/Deeds required to be signed between Indian Oil Corporation Limited and Department under Central Government/State Government (Uttar Pradesh, Bihar, Jharkhand) and Public Sector Undertakings, for example District Administration, PWD, Irrigation Department, Forest Department, Railways, Airport Authority of India, National Highway Authority of India etc. in respect of construction of the (a) Augmentation of Paradip-Halida-Durgapur LPG Pipelines and its extension up to Patna and Muzzaffarpur in Bihar and Jharkhand (b) 18" Halida Barauni Pipeline in Bihar and Jharkhand (c) Branch Pipeline from Patna to Baitalpur on Barauni-Kanpur Pipeline and its extension to Raxaul (d) Motihari-Amlekhgunj Pipeline
- 2) To consider and after obtaining due approvals from Competent Authority/ies negotiate/release/hold payment/s for any advance/ claims/ demand which is raised/payable in connection and context of the stipulations of the MOUs/Agreements entered into between Indian Oil Corporation Limited and departments under Central Government/State Government (Uttar Pradesh, Bihar, Jharkhand) and Public Sector Undertakings, for example District Administration, PWD, Irrigation Department, Forest Department, Railways, Airport Authority of India, National Highway Authority of India etc.
- 3) To institute, defend, prosecute, conduct, refer to arbitration, abandon and compound any legal or other proceedings, claim and dispute by or against the Corporation or in which the Corporation may be concerned or interested.

In addition to above, Construction Office, Patna is looking after 30" Haldia Barauni Pipeline in Bihar and Jharkhand & City Gas Distribution Projects in Bihar & Jharkhand which requires to be included in the Special Power of Attorney.

The following may be incorporated in the Special Power Of Attorney in 1) A):


- I. 30" Haldia Barauni Pipeline in Bihar and Jharkhand
