

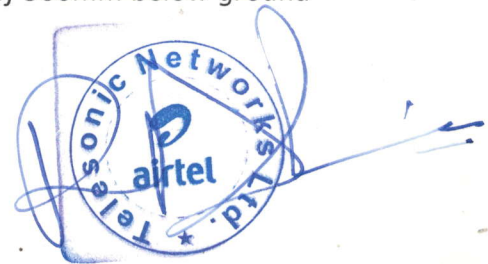

As such, to set up our network in different parts of Meghalaya, we have been laying Optical Fiber Cable in different routes and one such road is PWD road where at present we are undertaking our work.

In the stretch between Krishnai to William Nagar the PWD is passing through reserve forest area in two patches the forest clearance is therefore sought in this regard.

The Project is of Laying of Optical Fiber Cable inside HDPE ducts of 40 mm Dia by ~~HDD Method (Horizontal Directional Drilling) a Pit of Size 1mtrX1mtr X1.2 mtr Depth of an interval of 100 mtrs along the route. (Diagram Attached). Also Concrete Chambers with Lid will be installed along the route at an interval of 1 km at a depth of 500mm below ground level.~~
