COST-BENEFIT ANALYSIS

EVALUATION OF BENEFITS

1. Increase in productivity attributable to the specific project:

The given location of the project is well connected through road and Railways, and the presence of a huge workforce/labourers around the project, has potential of creating skilled as well as unskilled job opportunities. Besides, the project will build a sense of security among the urban population and will develop confidence among the working population and businessmen to take up new business projects in the city and implement them without any fear or hiccups.

The project will use the land for non harmful activities related to the environment like building offices, accommodation, Park, Sports Complex, PT Ground etc. which will further give a healthy environment to the city.

Taking maximum out of minimum resources, has been a flourishing culture of the CRPF and the land will be used to the best of its capacity without being a threat to the environment. Further, we can teach the nearby population the eco friendly techniques like rain water harvesting, tree and flower plantation, waste water management etc.

2. Benefits to economy:

The proposed site is surrounded by many micro and macro industries the smooth functioning of which is not possible without a secured administration and sense of security. The CRPF Battalion will boost a confidence among the business communities, transport and the industries which will facilitate smooth functioning of the economy. Also, the presence of CRPF at the proposed location will boost economy by creating job opportunities and may more business ventures will come up around the project, once they are given a fear free environment by the CRPF.

3. No. of population benefitted:

Since the CRPF is constantly engaged in dealing with internal security problems, the overall population is likely to be benefitted by the establishment of the CRPF Camp. The area is surrounded by tribal communities and the Left Wing Extremism has blocked the way of the development of these communities. The rural population is cut off from the cities and the presence of CRPF at the given location will build and link between these rural and urban population since its Sub-Units are deployed in far flung areas.

The skill as well as unskilled labourers will be given various tasks in the establishment of the CRPF Battalion like building accommodation, walled structures, Parks, PT Ground, Barracks, Lines, Mess, Electricity, Painting, Carpentry etc. Thus the establishment of the CRPF at the given location has a huge employment potential.
