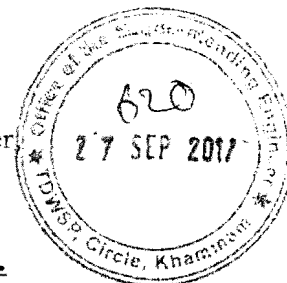

It is submitted that, the State Govt. vide reference 1st cited has accorded stage -I approval for Diversion of 4.519 Ha of Forest land in erstwhile Kothagudem Division and presently Kothagudem (0.049 Ha) and Yellandu (4.470 Ha) forest divisions for laying of Pipeline and Construction of structures in Segment - 25/15 (9th mail Thanda) for providing safe drinking water under Telangana Drinking Water Supply Project in favour of Superintending Engineer, TDWSP (RWS&S) Circle Khammam, subject to fulfillment of certain conditions stipulated therein.

Further, the PCCF,TS Hyd vide reference 2nd cited has issued instructions to take further necessary action to issue demand notice to the User Agency in consultation with the Nodal Officer for Forest (Conservation) Act-1980, for payment of Compensatory Lavies like cost towards raising & maintenance of compensatory Afforestation, Net Present Value (NPV), etc., in one go. Further, instructed to raise the demand with the User Agency as per the actual rates. Before issue of demand notice, he should submit the demand note to this office for vetting. Only after vetting of the demand note by this office, the District Forest Officer, should raise the demand with the user agency, who in-turn has to upload the demand online on Ministry's portal, generate challan & transfer funds through online into Ad-hoc CAMPA account of telangana.

In compliance of the above instructions, draft demand notice is prepared and submitted to the Principal Conservator of forests, TS, Hyderabad for vetting. Accordingly the Principal Conservator of forests, TS, Hyderabad has approved the demand and instructed to raise the demand with the User agency. Therefore, the Superintending Engineer, TDWSP (RWS&S) Circle, Khammam is

requested to make the following payments to the specified accounts. Further, it is requested to upload the demand online on Ministry's portal, generate challan & transfer the funds through online only into the specified Ad-hoc CAMPA account of Telangana State. 

To generate the challan, the User Agency has to enter the details of demand notice raised in Ministry's web portal, which has to be vetted by the Nodal Officer, FCA, Telangana State. The Challan has to be generated by User Agency, depositing into Saving bank Accounts maintained in either of the Banks mentioned below.


