Diversion of 39.468 Ha of forest land for construction of 132kV S/C on D/Ctower transmission line from Chimpu to Holongi under Comprehensive Scheme project of Arunachal Pradesh.



		possession value of forest land whichever is maximum	However, in case of transmission line projects, possession of diverted forest land is not completely required by the User Agency after completion of the project & during operation and maintenance (O &M) stage. As per existing MoEF guideline, dwarf species plantation will be undertaken below the transmission line corridor (RoW) by Forest Department. Only looping & pruning of tree branches near the electric conductor will be required during the maintenance period of the project
6	Cost of suffering to oustees	The social cost of rehabilitation of oustees (in addition to the cost likely to be incurred in providing residence, occupation and social services as per R&R plan) be worked out as 1.5 times of what oustees should have earned in two years had he not been shifted.
