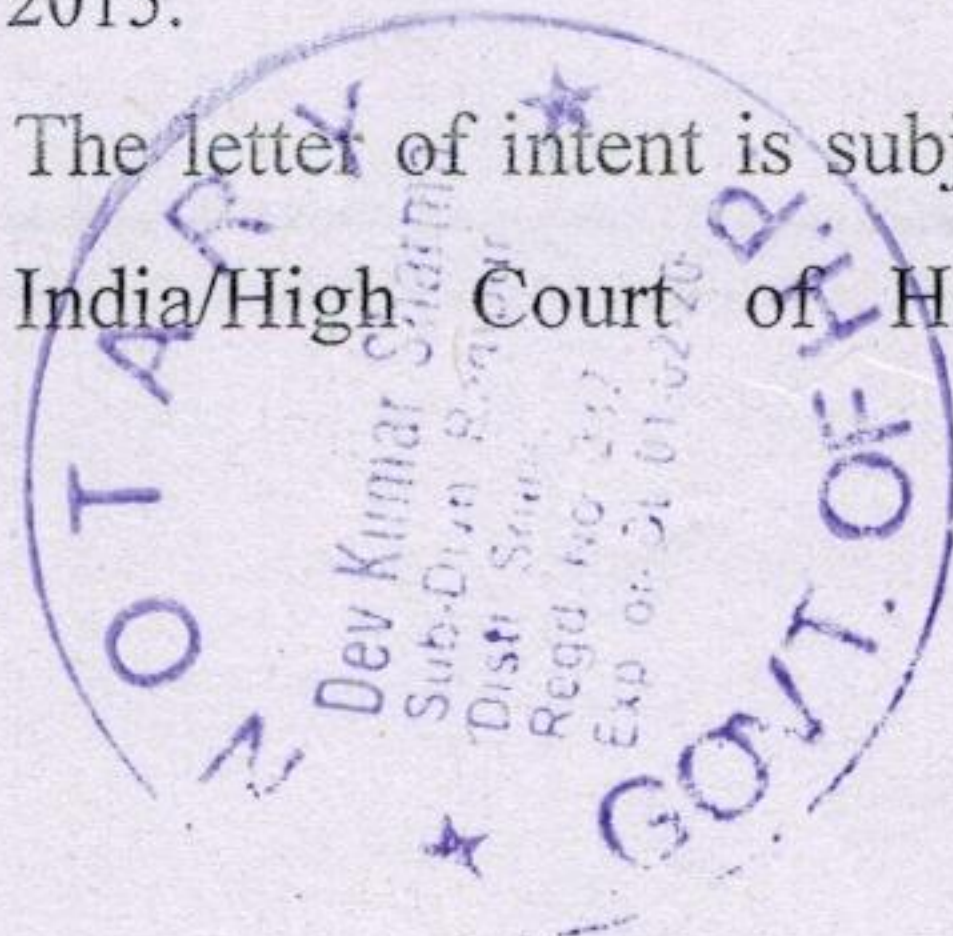

LETTER OF INTENT

Smt. Kanegtu Devi Prop. M/s Bushahar Laghu Udyog Udyo, Village & P.O. Jhakri, Tehsil Rampur, Distt. Shimla, H.P. has applied for grant of mining lease for extraction of Stone from Khasra No. 13/1, 13, 14, 22, 121/1 and 121/2, falling in Mauja Pashada, Tehsil Rampur, Distt. Shimla, H.P. measuring 02-23-50 Hectare, (Govt. land) for use in already established stone crusher under the provisions of Himachal Pradesh Minor Minerals (Concession) and Minerals (Prevention of Illegal Mining, Transportation and Storage) Rules, 2015. The case was referred to the Joint Inspection Committee for inspection of the area applied for mining lease and on the basis of recommendation of Joint Inspection Committee, the letter of intent over an area totaling 01-46-12 Hectare, bearing Khasra No. 13/1, falling in Mauja Pashada, Tehsil Rampur, Distt. Shimla, H.P. is hereby issued subject to the following conditions:-

1. The party shall get the area demarcated from the revenue authorities and shall erect permanent boundary pillars to the satisfaction of the Mining Officer, so as to clearly depict area applied for mining lease, which was recommended by the Joint Inspection Committee. A copy of the demarcation report shall also be submitted to the Mining Officer.
2. The party shall have to submit the approved Mining Plan under Rule 35 (1) of Himachal Pradesh Minor Minerals (Concession) and Minerals (Prevention of Illegal Mining, Transportation and Storage) Rules, 2015.
3. The party shall have to obtain Environment Clearance under Environment Protection Act, 1986.
4. The party shall have to obtain the Forest Clearance under the provision of Forest Conservation Act, 1980 from the competent authority.
5. The party shall comply the provisions of new rule i.e. the Himachal Pradesh Minor Minerals (Concession) and Minerals (Prevention of Illegal Mining, Transportation and Storage) Rules, 2015.

The letter of intent is subject to any orders passed by the Hon'ble Supreme Court of India/High Court of Himachal Pradesh or other concerned



Departments from time to time in this regard. This letter of intent is valid only for obtaining Environment clearance Under EIA and other required clearances/approval as mentioned above.

The grant order imposing all the conditions and stipulations relevant as per rule shall be issued only after submission of documents as mentioned at condition No. 1 to 4 above and after completing requisite codal formalities. This letter of intent shall be valid for a period of one year. Thereafter, extension of period shall be granted only after reviewing of the progress made for fulfillment of the above said documents. The party shall not resort to any mining activities till the execution of mining lease.
