
#### ADDITIONAL PROPOSAL FOR DIVERSION OF FOREST LAND FOR IMPROVEMENT OF AKAJAN-LIKABALI-BAME ROAD KM 65.00 TO KM 71.00 TO NHDL SPECIFICATION IN WEST SIANG DISTRICT OF ARUNACHAL PRADESH.

1. As part of the development of National Highways MoRT&H has decided for Improvement of connecting Akajan-Likabali-Bame Road KM 65 to Km 71. The existing length of project road is 6 Km and passing through districts of West Siang and comes under Alao Forest Division. The Road Akajan-Likabali-Bame is a vital link and the line communication for the local inhabitants of the forward area of District Upper Subansiri, West Siang, East Siang and Upper Siang Districts of Arunachal Pradesh. Up gradation of this road is very important not only from the point of connectivity but also from the strategic defence point of view. The construction of the road will also ensure development to the otherwise remote areas in this region.

2. The Proposed Additional diversion of forest area has been done due to a large number of representation of villagers and further representation by District Administration for the reasons for safety of Rilu village at km 65.00 to km 68.60 and accordingly length 3600 m has been left for is which has been taken in the earlier forest clearance proposal, final approved vide letter No. F. No. 3-AN C 023/2013-SHI/289-90, Dated. 27<sup>th</sup> April 2017 and accordingly length has been shortened to 1400 mtr (Design Chainage 65.00 to Chainage 66.400). Additional Muck dumping area 4.137 Ha has also been taken for the muck generated during the cutting.

3. More specifically, the project will:-

- (a) Enhance the road condition and use ability of the Trans Arunachal Highways, increase travel speeds, and reduce travel time, accident, and vehicle emissions.
- (b) Ensure more efficient road asset development and management, and higher quality of construction and maintenance, resulting in decreased recurrent costs over the medium and long term.
- (c) Accelerate the social and economic development in the state through improves access to socioeconomic services, increase employment opportunities, and improve transport services.
- (d) Better approach to Medical & Educational service and quick transportation of perishable goods like fruits, vegetable and dairy products.

#### Minutes of the Fifth Highway Monitoring Committee Meeting held in the Chief Secretary's Conference Hall, Itanagar at on 23<sup>rd</sup> May, 2016.

The 5th Highway Monitoring Committee Meeting was held in the Conference hall of the Chief Secretary, Govt of Arunachal Pradesh, Itanagar on 23rd May, 2016. The meeting was chaired by **Mrs. Shakuntala D. Gamlin**, **Chief Secretary**, Government of Arunachal Pradesh, Itanagar. The list of participants from various departments/organizations is annexed at Annexure-A.

At the outset, Sri Tajom Taloh, Commissioner (PWD) while welcoming all the participants to the 5<sup>th</sup> Highway Monitoring Committee Meeting had emphasized on the importance of resolving all pending issues of highway implementation so as to enable completion of the projects on schedule and avoid time-cost overrun by all the executing agencies.

The follow-up action on decision of the Fourth Highway Monitoring Committee meeting held on 26th November'2015 were reviewed through Power-Point Presentation by Shri T. Basar, Chief Engineer, Highway, Eastern Zone, PWD, Itanagar along with on-going Highway Projects/package of PWD Highway zones in details and NHIDCL, BRO and MoRT&H project in brief, new Highway proposal in principle agreed by MoRT&H, GoI and new railway line proposal from Govt. of Arunachal Pradesh to Railway Ministry in all foothill town of Arunachal Pradesh and deliberations/decisions arrived are as under:-

1. The ADG(E), BRO said that there are no clear guidelines of the Department of Mines & Minerals of the state on the issue of payment of compensation/ monopoly to the private quarry owners for extraction of road materials. Further, for the road materials/aggregates procured from quarries of Assam, BRO is required to pay entry fee at the check gates at the interstate check gate leading to double taxation. The BRO has requested the state government to resolve these two issues so that such materials can be procured / extracted from notified private quarries at Govt' approved rates/compensation fees (lease rate) and enable the BRO to procure from within the state and from Assam as per requirement.

It was decided by the Chief Secretary that the BRO will submit specific proposal to the State Govt. so that Department of Mines & Minerals can process for cabinet decision if required. (Action - ADG(E) BRO / Secy Mines & Minerals)

- 2. Mandatory clearance of state pollution control board for Highway Projects -Chief Engineer, Highway, E/Z has informed Environment clearance for quarry operation permission has not yet been granted by SPCB yet although detail requirement formalities are furnished through forest department to SPCB by M/s Navayuga Agency who is executing Alubari Bridge system and approach road. It was also instructed to submit list of such proposal received by SPCB from Highway Construction Agencies / Concessionaire to Chairman, HMC (i.e. Chief Secretary) (Action - Member Secy, SPCB)
- 3. On the issue of RTGS payment for final forest/wild life clearances, the representative of State Forest Department had pointed out that the matter of excess payment remained unresolved. The CAMPA/MoEF, New Delhi vide their letter dated 19<sup>th</sup> February 2106 has informed that the common RTGS reference contains payment in excess of estimated cost for Wildlife Management Plan. Therefore, the Regional Officer, MORTH, (Itanagar) Tezpur has to furnish project wise bifurcation of payment already made with package-wise references so that the discrepancy as pointed out by CAMPA can be reconciled for resolving the long pending issue. (Action RO, MORT&H, Itanagar, Camp Tezpur)
- 4. Deputy Commissioner, Roing clarified on the issue of pending Land Availability Certificate for the Dibang Bridge stating that there is nothing called Land Availability Certificate. The compensation for the land acquisition has already been disbursed except for three persons. The report of the contracting agency saying that the work progress has been frequently stalled due to law and order problem is not correct. On one occasion it was verified that the work was stopped by the workers of the company for non payment of wages. The Deputy Project Manager of the

contracting agency was also called to clarify on the issue. The Chief Secretary directed the contracting agency not to misrepresent facts in order to cover up the delay in completion of the work due to reasons attributable solely to the agency and not to the state government. The contracting agency reported that the work will be completed by September 2016. (Action - PM & DPM, M/s Navayuga Dibang Bridge)

5. Pending Forest Clearance issues in MOEF, Shillong/ Delhi – The Chief Engineer, Highway Eastern Zone, PWD, AP, Itanagar informed that there are some Forest Clearance proposals pending in Ministry of Environment & Forests, New Delhi and their Regional Office at Shillong for Final Clearance. The Committee requested the CCF & NO (FCA), Department of Environment & Forests, Itanagar to look into the matter. CCF & NO (FCA), Department of Environment & Forests, Itanagar is requested to look into the pending cases as tabulated. If required DO letter be put up for Secretary, MoEF, Gol for clearance of MoEF, Gol.

# 6. Finalization of compensation package of Potin- Pangin Road (NH-13)

It has been decided that the re-verification of the Land Acquisition (i) Estimate of the Upper Subansiri district by the committee constituted by the GOAP under chairmanship of Shri Ashok Kumar, Secretary (Vigilance/APPSC) from Bopi to Tai (157.27 km) should be constructed in time bound manner so that the issue is resolved early to enable the concessionaire to start the construction of the BOT (highway) project immediately. The matter has been unduly delayed already since the appointed date was fixed in July'2014. (Action - Shri Ashok Kumar, re-verification /APPSC Chairman Vigilance IAS, Secretary Committee)

stretch from Tai to Gabu Stream (94.04 km) under West Siang district, although the Estimate of LA which has been submitted to MORTH is not yet sanctioned. CE HW WZ informed that all the clarifications/observations raised by the Ministry on the DPR of LA has been attended to and the same is likely to be sanctioned by the end of May'2016. (Action - DC, West Siang Aalo / Chief Engineer, HW(W/Z).

DC Aalo further informed that although the fund for utility shifting has been deposited with the line agencies like the Power and PHE departments, the shifting of utilities are yet to be accomplished. It was therefore decided in the meeting that the DC Aalo will conduct an inquiry into the matter and find out the facts for further necessary action of Govt. (Action - DC, Aalo conducting enquiry).

- (iii) The LA Estimate of Gabu Stream to Pangin (914.30 km) under Siang district has been received for Rs.61054515 from DC Siang by CE HW WZ and the same will be submitted to MORTH by 24.5.2016. (Action Chief Engineer, HW(W/Z)
- **7.** For the portion from Potin to Bopi(157.27 km) under Lower Subansiri district the following decisions was taken :
- I) The DC Ziro will have to play a proactive role to re-verify the land acquisition(LA) estimate and resubmit without further delay.
- II) Considering the technicality, safety, future expansion requirement as well as the conversion of the airport to dual use purpose for defence civilian aircrafts, the highway alignment has to be taken beyond 900 m away from the airport at Ziro as recommended by the Indian Air force (IAF).
- III) The high cost of the LA compensation estimate from Potin to Bopi is due to the fact that it passes through the thickly built-up area within the Ziro Township. Therefore, it has been decided that the highway alignment should now by-pass the Ziro Township. If required re-assessment of LA shall be done by the committee constituted by state govt. under the chairmanship of Shri Ashok Kumar, IAS, Secretary Vigilance / APPSC help can be taken by DC, Ziro (Action RO, MoRT&H / CE, HW(W/Z), DC, Ziro)

#### 8. Implementation/maintenance of Akajan-Likabali-Bame Road

I) The Chief Secretary expressed serious concern on the poor road condition on this sector. The implementing agencies appraised the house about the, limited scope for maintenance of the road during construction. However it was decided that the agency will maintain the road traffic worthy. M/s JKM - KCL and M/s T. K. Engineering Consortium Pvt. Ltd. who are working on this sector will take immediate necessary action in the coming two months periods, & un-awarded portion of road Rimi to Basar should be finalized by NHIDCL immediately along with existing road, improving road geometrics works be awarded in current financial year for completion of entire road construction before 2017. (Action - GM, NHIDCL /DC, Aalo)

#### II) Protection of Rilu village

It was brought to the notice by the DC Aalo that as per approved alignment the Rilu village on Akajan-Bame road is completely dislocated. It was instructed that NHIDCL will ensure that the village is protected with necessary realignment of the road on this stretch. Realignment will not only protect the village but also improve the road geometrics as opined by the DC, Aalo and also requested to maintain road length, connecting TAH approximately 1 Km from present Tri-junction Bame - Tirbin Aalo road to where TAH proposed to connect near PMGSY road at Nyorak by NHIDCL / MoRTH / Concessionaire. (Action - GM, NHIDCL / RO, MORT&H)

### 9. Status of the delayed projects under PWD:

Agencies have revised target date of completion and committed to complete the projects in revised given time without escalation as all of completion stipulated time has already lapsed.
