Sub: For diversion of 0.9459 Ha of Forest Land in Kondapak RF of Siddipet Forest Division of Medak Circle for formation of approach road from Main road to reach quarry lease site of M/s Abhaya Hanuman Mining Company situated in Sy.No.54 (Govt. land), Mathapally Village Kondapaka Mandal of Siddipet Division in favour of M/s Abhaya Hanuman Mining Company-submission of proposals – Reg.

Please refer to your office letter/proceedings cited above wherein it was advised to submit the proposal for diversion of forest land under Forest (Conservation) Act, 1980 along with all the necessary documents, besides uploading the application online.

Accordingly, we hereby submit the proposal as mentioned in the rules governing FC Act-1980 for kind perusal in (8) Sets. We submit the full justification in the relevant coloum for seeking diversion of Forest land of **0.9459 Ha** in part-I of Form-A.

It is also to submit that we have explored the entire alternatives for formation of road through non-forest land and only after exhausting all the options, we have proposed this formation of road through Forest area.

The quarry and crushers units in question are falling in Mathapally Revenue Village limits and it is outside the Reserve Forest Area (nearest RF of Kondapak is existing at a distance of 0.6 km).

As of now, we were using the existing road which is passing through the village of Mathapalli to reach the quarry and crushers units sites and also for transportation of quarry & crushed material to nearyby Mandal Head Quarters. The said road is passing through dense populated village main road and due to which the villagers are objecting for movement of trucks from the villages.

We are submitting proposal for diversion of forest land for 0.9459 Ha is required 1891.84 M in length * 05 M in width, as our case is genuine and kindly be considered by taking the following facts in to consideration:-

1. We are not causing any loss or harm to the habitation of forest including wild life as the forest land proposed under Diversion is completely on the Edge/boarder line boundary of Reserve Forest.
2. We can't buy/purchase any pvt lands, as we have tried to convince the adjacent owners for allotment of land for our approach road, but they have declined our proposal, as they are assigned government lands allotted to landless poor.

The proposal is also uploaded on the Ministry's portal, acknowledgment copy is enclosed for ready reference.
