RECORD OF DECISIONS OF DLC ON FOREST RIGHTS, DHALAI (BY CIRCULATION) ON 28th May, 2021.


In compliance of the Ministry of Environment and forests (MoEF), Government of India's letter No. 11-9/98-FC(pt.) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right) Act 2006 on the forest land proposed to be diverted for projects other than linear projects and plantations and it is certified that **5.00 hectares** of forest land to be diverted in favour of **Revenue Department Govt. of Tripura for Addl. Bru Migrant Settlement at Bongafa Para** falls within jurisdiction of **Labancharra ADC village, Mouja : MCRF, TK : Chailengta under Longtharai Valley Sub-Division of Dhalai District.**

The committee members expressed satisfaction to processes for identification and settlement of rights under FRA and also propose diversion of **5.00 hectares** of forest area for projects other than linear projects and plantations in favour of **Revenue Department Govt. of Tripura, for Addl. Bru Migrant Settlement at Bongafa para.**

Taking reference from the reports submitted by the Sub-Divisional Magistrate, Longtharai Valley and resolution of Gram Sabha Committee members and SDLC of RoFR Act, 2006 hereby it is confirmed that the proposal does not involve recognized right of Primitive Tribal Groups and Pre-agricultural communities.



TO WHOMSOEVER IT MAY CONCERN

In compliance of the Rule 6(3)(e) of the Forest (Conservation) Rules, 2003 [as amended vide the Forest (Conservation) Amendment Rules 2014; Forest (Conservation) second Amendment Rules 2014; and Forest (Conservation) Amendment Rules 2016] it is certified that **5.00** hectares of forest land proposed to be diverted in favour of **Revenue Department Govt. of Tripura** (name of user agency) for **Addl. Bru Migrant Settlement at Bongafa Para** (purpose for diversion of forest land) in the district falls within the jurisdiction of **Labancharra** ADC village(s) Mouja : **MCRF** in **Chailengta** tehsils. It is further certified that:

(a) the complete process for identification and settlement of rights under the FRA, 2006 has been carried out for the entire **5.00** hectares of forest land proposed for diversion. A copy of records of all consultation and meetings of the Forest Rights Committee(s), Gram Sabha(s), Sub- Division Level Committee(s) and the District Level Committee are enclosed as attachment Annexure - I to attachment Annexure - IV;

(b) the proposal for such diversion (with full details of the project and its implications, vernacular/ local language) have been placed before each concerned Gram Sabha or forest-dwellers, who are eligible under the FRA, 2006:


(c) each of the concerned Gram Sabha(s), has certified that all formalities/ processes under the FRA have been carried out, and that they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any, having understood the purpose and details of proposed diversion. Copies of certificate issued by the Gram Sabha(s) of **Labancharra** ADC villages(s) are enclosed as attachment Annexure - I.

(d) the discussion and decisions on such proposals had taken place only when there was a quorum of minimum 50 % of the members of Gram Sabhas present;

(e) the diversion of forest land for facilities managed by the Government as required under Section 3 (2) of the FRA have been completed and the Gram Sabhas have given their consent to it;

(f) the rights of Primitive Tribal Groups and Pre-Agricultural Communities, where applicable have been specifically safeguarded as per Section 3 (1) of the FRA, 2006.

Resolution of the Sub-Divisional Level Committee meeting (RoFR), Longtharai Valley Dhalai Tripura

A meeting with the members of Sub-Divisional Level Committee of Scheduled Tribes and Others Traditional Forest Dwellers (Recognition of Forest Right) Act 2006, was held on 17/05/2021 in the Conference hall of SDM Office Longtharai Valley, Dhalai Tripura, in connection with approval of Addl. BRU Migrant settlement in the Plot No. 304/p Khatian No.44/14 of areas measuring 3.00 hactres and Plot No. 400/p Khatian No.44/23 of areas measuring 2.00 hactres under MCRF mouja with total areas measuring 5.00 hactres of forest land at Bongafa para under Labancharra V/C.

After detail discussion and adopted resolution of Village Level Forest Rights Committee of Labancharra ADC Village, that the SDLC (RoFR), LTV made a resolution that the committee do not have any objection for diversion of 5.00 hectors of Forest land in favour of BRU Migrant settlement.

It is also certified by the committee that identification and settlement of rights under FRA 2006 has been carried out for the entire 5.00 hactres forest land as per Schedule Tribes and Others Traditional Forest Dwellers (STOFD) Act 2006. The schedule land is mentioned below :-
