
In inviting a kind reference to the letters cited above, demand is raised to the tune **Rs.90,95,780/- (Rupees Ninety Lakh, Ninety Five Thousand, Seven Hundred, Eighty)** only for involvement of 14.530 ha forest land for the above project in Jharsuguda district for construction of Aherajore Irrigation (Barrage with Canal) Project at village Debadarah and other villages coming within the canal alignment in Lakhanpur Block of Jharsuguda district of Odisha on the basis following field report & calculation.

(1)	Eco-value class of the forest crop available in the locality.	Class-III
(2)	Canopy density of the crop available in the locality	Below 40%
(3)	Rate of NPV per ha applicable with reference to the field report	Rs.6,26,000/-
(4)	Total NPV (6,26,000 x 14.530 = Rs.90,95,780/-	Rs.90,95,780/-

So, you are requested to deposit **Rs.90,95,780/- (Rupees Ninety Lakh, Ninety-Five Thousand, Seven Hundred, Eighty)** only towards Net Present Value (NPV) in the State Specific CAMPA Account maintained by Govt. of India through "E" Payment in Union Bank of India, Sundarnagar Branch, New Delhi-110003 or in Corporation Bank, CGO Complex, Lodhi Road, New Delhi-110003 by using the Web Portal of Ministry of Environment & Forests (CAMPA). A copy of guideline for remittance of CAMPA Funds through Web Portal by the UA is enclosed herewith for ready reference. Further, the evidence of depositing the amount may be forwarded to the undersigned for further needful action at this end.


