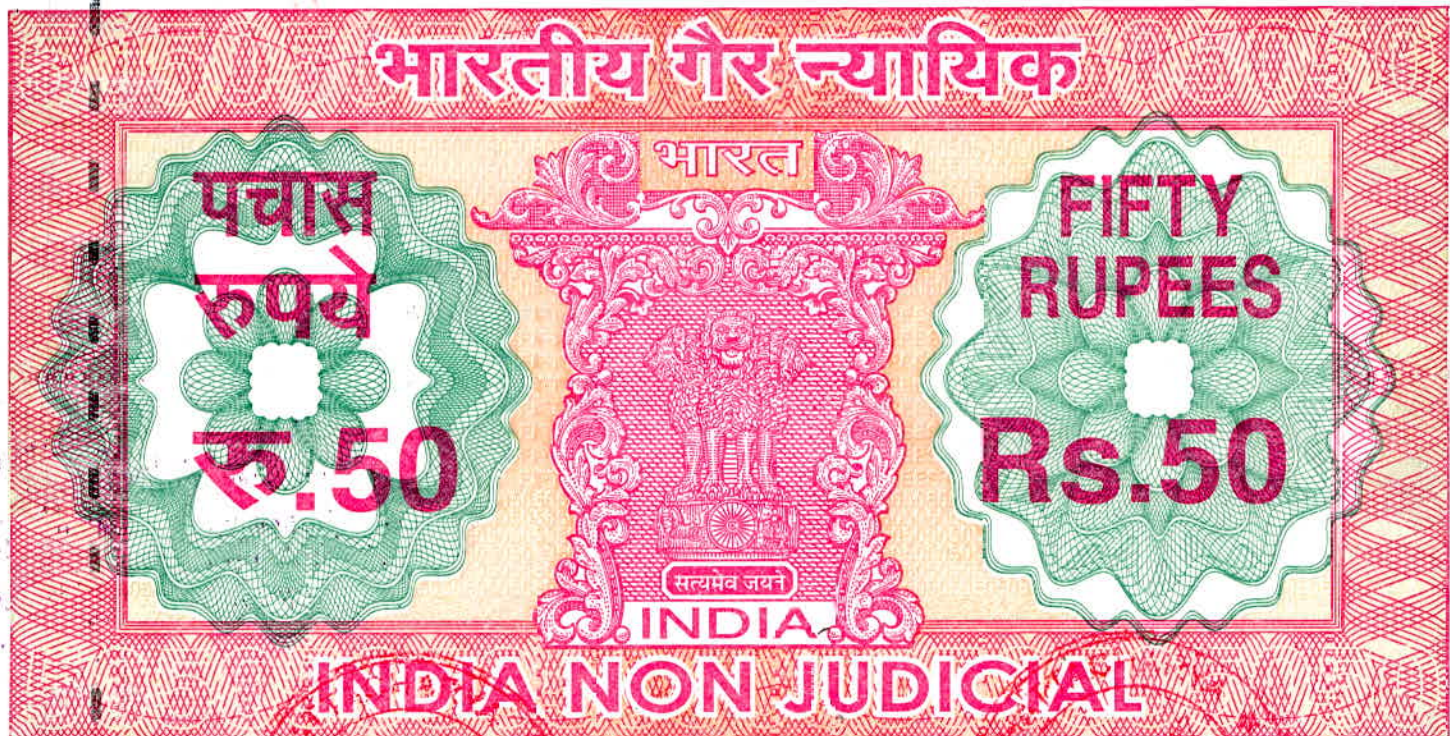

GENERAL POWER OF ATTORNEY

1. To institute, conduct, defend, compound, compromise and abandon or withdraw suits, appeals or other legal proceedings by or against the company or its officers or otherwise concerning the affairs of the company.
2. To sign and verify plaints, written statements, memorandum of appeal, writ petitions, applications, revisions, statements, counter-statements, rejoinders and any other documents and papers required to be filed in connection with case(s) before court of law, tribunals, arbitrators, umpires or other authorities and swear and affirm affidavits in connection thereto.

5. To present deeds and instruments, whether executed by the Attorney or any other authorized person on behalf of the company for registration before Registrar, Sub-Registrar or any other registering officer and admit execution thereof on behalf of the company.
6. To sign and execute indemnity bonds, bid bonds, performance bonds, cheques and other negotiable instruments and acceptances and endorsements.
7. To recover money, refunds and receive moneys, payment on behalf of Steel Authority of India Limited, Raw Materials Division and to give valid discharge and execute receipts.
8. To make payments, to deposit moneys and settle claims on behalf of Steel Authority of India Limited, Raw Materials Division and to obtain valid discharge or receipts for the same.
9. To deal with banks, licensing authorities, tax departments, etc. and to correspond with them in regard to bank accounts, licenses etc. held by Steel Authority of India Limited, Raw Materials Division as may be necessary or ancillary or as may be required in the exercise of the functions under this Power of Attorney.

And I agree and undertake to ratify whatever the said Attorney shall lawfully do by virtue of power conferred on him by these presents.
