In compliance of the Ministry of Environments and Forests (MoEF), Government of India's letter No. 11-9/98-FC (pt.) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights, under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes, it is certified that **0.0250** Acres (more or less), Dungdungia-2 forest land proposed to be diverted in favour of Reliance Jio Infocomm Limited, Godrej Waterside Building, Tower II, 17th & 18th Floor, Sector 5, Salt Lake, Kolkata - 91 for installation of Reliance Jio 4G Tower in Jorebunglow Sukhiapokhri Development Block in Darjeeling district falls within jurisdiction of Darjeeling Sub-Division.

- (a) the complete process for identification and settlement of rights under the FRA has been carried out for the entire **0.0250** Acres (more or less) Dungdungia-2 forest land proposed for diversion. A copy of records of all consultation and meetings of the Forest Rights Committee(s), Gram Sabha(s). Sub-Division Level Committee(s) and the District Level Committee are enclosed as annexure A to annexure B.
- (b) the proposal for such diversion for installation of Jio 4G Tower under Jorebunglow Sukhiapokhri Block, Darjeeling sub-division have been placed before each concerned Gram Sabha of forest-dwellers, who are eligible under the FRA.
- (c) the concerned Gram Sabha(s), has certified that all formalities/ processes under the FRA have been carried out, and that they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any, having understood the purpose and details of proposed diversion. A copy of certificate issued by the gram sabha of Majidhura Balasan Forest Village is enclosed as annexure A.
- (d) the discussion and decisions on such proposals had taken place only when there was a quorum of minimum 50% of the members of Gram Sabha present.
- (e) the diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Gram Sabha have given their consent to it;
- (f) the rights of Primitive Tribal Groups and Pre-Agricultural Communities where applicable have been specifically safeguarded as per section 3 (1) (e) of the FRA.

Meeting started the Chairman assumed the chair. Individual claims as received on Form A and the Community Claims in Form B and also along with the no objection for erection of mobile JIO Towers coming under the forest lands under the Forest Right Act, 2006 in the Darjeeling Sub-Division, were taken up. The three blocks namely Darjeeling —Pulbazar, Rangli- Rangliot and Jorebunglow- Sukhiapokhari processed the clams and after finding as many as those fit submitted to the SDLC.

- For Darjeeling Pulbazar, Rangli- Rangliot and Jorebunglow Sukhiapokhari Development Blocks the following Forest Villages were taken up for recommendation after scrutiny
  - Darjeeling –Pulbazar Development Block:-
    - 1. Rithu Forest Village.
    - 2. Pal Majuwa Forest Village.
  - Rangli- Rangliot Development Block:-
    - 1. 3<sup>rd</sup> Mile Forest Village.

# Jorebunglow-Sukhiapokhari Development Block:-

1. Ghoom- Bhanjyang Forest Village.

As discussed on previous meeting the SDLC noted that all the claims pertaining to the Other Traditional Forest Dwellers (OTFD) needs further verification as to their antecedents since 75 years till the effect of the Act and or atleast past three generations. As such, the claims relating to OTFD presented and scrutinised by the SDLC and some of the OTFD Claims of Three blocks viz. Darjeeling- Pulbazar, Rangli-Rangliot and Jorebunglow- Sukhiapokhari Development Block where scrutinised again and were found satisfactory.

For the ST Claimaints the cut off date is 13.12.2005. On scrutiny the following ST claims were found to be proper backed by satisfactory documentary evidences. Those claims lacking ST Certificate of the claimaints / his or her father has been returned back. For the Darjeeling –Pulbazar Development Block Rithu Forest Village 11 ST Cases were approved for DLC and 04 OTFD cases passed with the request to Block Development Officer to sent back with proper verification and Under Pal Majuwa Forest Village all 18 number of OTFD Cases were approved. 3<sup>rd</sup> Mile Forest Village under the Rangli- Rangliot Development Block 38 ST and 61 OTFD were passed for DLC and under Jorebunglow- Sukhiapokhari Development Block Ghoom Bhanjyang Forest Village 84 Cases were presented among which 61 has been approved for DLC and the rest claims each have been rejected on ground of non availability of ST Certificates. The concerned Gram Sabha and Forest Right Committee have been advised to rectify the claims and re- send to the SDLC for further processing.


The community clam of Ghoom Bhanjyang Forest Village as reflected in Form B has been sent back for re-verification.

After the long discussion over the Forest Villages the committee also discussed over the Mobile Towers installation on the different places under the Forest Villages under Jorebunglow- Sukhiapokhari Dev. Block having three (3) Forest Villages among which (2) have been selected for the Installation, Rangli – Rangliot Dev. Block having one (1) Forest Village which has not been selected for the Installation due to non submission of NOC and under Darjeeling –Pulbazar there was no proposal for Mobile Tower Installation.
