It is to inform that, the Government has approved **(Stage-I)** for Diversion of 13.9887 Ha (Nirmal 9.7887 Ha and **Echoda 4.20 Ha** | revised from 8.0972) of forest land for erection of 220 KV DC line from 400/200 KV SS Nirmal to the proposed 220/132 KV SS Utnoor in Nirmal District under Thermal Power Transmission Scheme for evacuation of power from 4 x 270 MW units at Nirmal in favour of the Superintending Engineer, OMC Circle TS TRANSCO, Adilabad, passing through Reserve Forest areas in Boath range of Echoda Division of Adilabad District, duly stipulating certain conditions to be complied vide reference 1st cited and communicated by the Pri Chief Conservator of Forests, Telangana, Hyderabad vide reference 2nd cited.

Further it is informed that, vide reference 2nd cited, instructions have been issued for raise the demand to the user agency and mention correct account number for depositing the amount.

Further, it is proposed to provide twenty bird reflectors, which are to be fixed on the upper conductor of the transmission line at suitable intervals, and the user agency will be asked to fix same after erection of transmission line.

Further, the User Agency has to comply with following in accordance with the MoEF&CC, GoI instructions issued vide F.no.7-23-2012-PC, Dt.24.07.2013 communicated vide Prl. Chief Conservator of Forests, A.P. Hyderabad Rc.No.45921/2001/F4, Dt.23.08.2013:

1. Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the Central government in two widely circulated daily newspaper one in vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.

2. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

Further, the User Agency has to furnish the compliance on the conditions stipulated in the Stage I approval for onward submission to Government for obtaining Stage-II approval.

The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage II) approval or working permission.

Further the Superintending Engineer, OMC Circle, TSTRANSCO, Adilabad is requested to furnish the **copies of Paper clippings about the publishing of forest Clearance etc.**, as instructed by the Prl. Chief Conservator of Forests TS Hyderabad vide reference 2nd cited the said reference along with its enclosures are enclosed for their ready reference.

Further it is also informed that, this in-principle approval shall be valid for a period of 5 years. In the event of non-compliance of the above conditions, this in-principle approval shall automatically stand revoked after 5 years.

Further, the user agency shall follow the instructions of the Nodal Officer / Pri CCE,TS,Hyderabad issued vide reference 5th cited scrupulously and the User Agency has to comply with following in accordance with the MoEF&CC, GoI instructions issued vide F.no.7-23-2012-FC, Dt.24.07.2013 communicated vide Pri, Chief Conservator of Forests, A.P. Hyderabad Rc.No.45921/2001/F4, Dt.23.08.2013.

Publish the entire Forest clearances granted in verbatim along with the condition and safeguards imposed by the Central government in two widely circulated daily newspaper one in vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.

The copies of the Forest clearance should also be submitted to the heads of local bodies, Panchayats and Municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

Further, the User Agency has to furnish the compliance on the conditions stipulated in the Stage I approval for onward submission to Government for obtaining Stage-II approval.

The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage II) approval or working permission.
