




- DGPS Survey of Compensatory Afforestation land identified in Northern R.F. in lieu of forest areas proposed for diversion for construction of 132/33KV Transmission line Grid S/s Boudh to proposed 220/132/33KV Transmission line Grid S/s Kiakata under OPTCL, Angul in Boudh and Angul districts of Odisha of the Deputy General Manager (Elect.), OPTCL, Angul has been carried out through M/s Centre for Envotech and Management Consultancy Pvt. Ltd, Bhubaneswar.
- DGPS Survey Co-ordinates are verified by ORSAC. Also Maps showing Compensatory Afforestation land are verified with surveyed points compared with Ortho-rectified Cartosat Satellite image and found that maps are correct at a confidence level of 95%.
- Total area proposed for Compensatory Afforestation comes in Northern R.F., Angul district and works out to 11.5Ha. from the submitted .shp files and detailed survey area.
