(Durgapur Steel Plant) over their lease hold
area of 6.90 sq.miles in Bolani area of
Keonjhar district beyond 13.5.83.

Sir,

I am directed to say that grant of renewal
of M.L. for iron and manganese over an area of 6.90 sq.
miles in Bolani area of Keonjhar district in favour of
M/s. SAIL is under consideration of the Government. Pending
final grant of the lease the Government have been pleased
to allow M/s. SAIL to work the mine for iron and manganese
beyond 13.5.83 till final execution of the renewed lease
subject to payment of advance rent, royalties and cess etc.
and subject to terms and conditions laid down in the model
form of lease deed in form-K of the M.C.Rules, 1960-

M & M(R&D) Act., 1957 and all other relevant Act & Rules
and regulations.

Further, the working permission is subject
to the following conditions:-

1. The working permission can not be cited as a claim
for grant of renewal of M.L. for iron and manganese
to the party.
2. The party should pay in advance royalty at the rate
prescribed in the second schedule to the M.M(R&D)
Act., 1957 surface rent, cess etc. before removal of
ores from the area.

3. Working permission is liable for cancellation at any time before its expiry as may be decided by the Government.
4. This working permission would stand cancelled immediately in case the Government of India would not approve the proposal of the State Government for grant of renewal of the lease to the party.

Sir,
I am directed to enquire whether you accept the
following terms and conditions that would govern the grant of
1st renewal M.L. Your reply as per enclosed proforma should
reach Government on or before 26.2.84 failing which it will be
considered that you do not accept the conditions.

The lease will be subject to the following terms
and conditions laid down in the Model Form of Mining Lease
adopted by the State Government and to the following conditions:

i) Royalty and deed rent should be paid at rates
provided in the Mines & Minerals (R&D) Act, 1971 and as amended
from time to time.

ii) Surface rent should be paid at the rate of
Rs. 2.50 per hectare for areas of waste lands and at rates not
exceeding the land revenue and cesses in respect of the
cultivable area and water rate as may be fixed from time to time
by Government.

iii) The renewal of the lease will be granted for a
period of 20 years with effect from 14.11.82.

iv) An amount of Rs. 1000/- should be deposited towards
security deposit for the observance of the terms and conditions
dictated above. The deposit shall be forfeited to the State if the
conditions are not observed in addition to such other remedies
or action as may be available under these premises.

v) The assignment will be liable to cancellation
if it is found that it was in excess of the limits of the
authority possessed by the State Government.

vi) The assignment will be subject to the result of any appeal or revision that may be preferred by any aggrieved party against the decision of the State Government granting you lease and in the event of the cancellation of the assignment or the decision of Government of Orissa to release the area to you either on such appeal or in revision you shall not be entitled to compensation for anything done or attempted to be done during or on the order.

vii) The area should be surveyed and measured by the State Government at the expense of the lessee under Rule 33 of the P.C.Rules, 1960. The party should forward the required amount of survey and compensation, if any, within a week of the receipt of the present order.
