







## Jammu & Kashmir Forest Department Office of the Pr. Chief Conservator of Forests & HoFF, Government of Jammu & Kashmir

Sub: Payment of compensatory levies in respect of PMGSY proposals for forest clearance having received in-principle approval from the competent authority.

The PW (R&B) Department, Government of J&K, has already paid compensatory levies amounting to Rs. 19,10,57,058/- into J&K CAMPA Account, in respect of PMGSY proposals submitted on PARIVESH portal under the provisions of the Forest (Conservation) Act, 1980. As on 14-05-2021, a total of 20 PMGSY proposals have received in-principle approval from the Government of J&K/Integrated Regional Office, Ministry of Environment, Forest and Climate Change, Jammu. The list of such proposals alongwith compensatory levies payable i.e. NPV, CA, Additional CA (amount on account of biological measures for stabilization of muck dumping sites) and penal CA in each such case is enclosed. C.A amount in respect of two proposals as indicated in the enclosed list will be reworked by the DFO concerned.

Thus the compensatory levies in all these cases in enclosed list may be treated as having been paid by PMGSY, and accordingly, the working permission and order for felling of trees shall be issued by the DFO/CF concerned after fulfilment of the other conditions stipulated in the in-principle approvals.
