TO WHOM IT MAY CONCERN

In compliance of the Ministry of Environment & Forests (MoEF), Government of India's letter No 11-9/98-FC (pt) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidence for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ("FRA for short") on the forest land proposed to be diverted for non-forest purposes, it is certified that 425.5 Hectares of forest land proposed to be diverted in favour of Calcom Cement India Ltd for Mining of Limestone in Distⁿ Council Khas land under NC Hills Division (W), Dima Hasao Dist and falls within jurisdiction of 19 KM (New Umranghsu) Village.

It is further certified that :

- (a) The complete process of identification and settlement of rights under the FRA has been carried out for the entire 425.5 Hectares of forest land proposed for diversion. A copy of records of all consultation and meetings of Forest Rights Committee(s), Gram Sabha(s), Sub-Divisional Level Committee(s) and the District Level Committee are enclosed as annexure. **NOT APPLICABLE in this area. Please refer to earlier certificate issued vide memo No FRS/Sectt/Calcom/134/2012-13/5-A dated 14th Aug, 2013 attached herewith.**
- (b) The proposal for such diversion (with full details of the project and its implications, in vernacular/ local language) have been placed before each concerned Gram Sabha of forest dwellers who are eligible under FRA; **NOT APPLICABLE in this area in view of sl. No. (a) above.**
- (c) The each of concerned Gram Sabha(s), has certified that all formalities / processes under the FRA have been carried out, and that they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any, having understood the purpose and details of proposed diversion. A copy of certificate issued by the Gram Sabha of NIL Village(s) is enclosed ; **NOT APPLICABLE in this area in view of sl. No. (a) above.**
- (d) The discussion and decisions on such proposals had taken place only when there was a quorum of minimum 50% of the members of Gram Sabha present ; **NOT APPLICABLE in this area in view of sl. No. (a) above.**
- (e) The diversion of forest land for facilities managed by the Government as required under section 3 (2) of FRA have been completed and the Gram Sabha have given their consent to it; **NOT APPLICABLE in this area in view of sl. No. (a) above.**
- (f) The rights of Primitive Tribal Groups and Pre-Agricultural Communities where applicable have been specifically safeguarded as per section 3(I) (e) of the FRA; . **NOT APPLICABLE in this area in view of sl. No. (a) above.**


