In compliance of the Rule 6 (3) (e) of the Forest (Conservation) Rules, 2003 [as amended vide the Forest (Conservation) Amendment Rules 2014; Forest (Conservation) second Amendment Rules 2014; and Forest (Conservation) Amendment Rules 2016] it is certified that (0.73 Hectare) of forest land proposed to be diverted in favour of Rural Development Department for the purpose of construction of Panchwati in Mandi District falls within the jurisdiction of village(s) Bhakrunda & DPF Suranda in Tehsil Karsog. It is further certified that:

- the complete process of identification and settlement of rights under the FRA, 2006 has been carried out for the entire 0.73 Hectare of forest land proposed for diversion. A copy of records of all consultation and meetings of the Forest Rights Committee(s), Gram Sabha(s), Sub-Division Level Committee(s) and the District Level Committee are enclosed as annexure I to V.
- the proposal for such diversion (with full details of the project and its implications, in vernacular/local language) have been placed before each concerned Gram Sabha or forest -dwellers, who are eligible under the FRA, 2006.
- each of concerned Gram Sabha (s), has certified that all formalities/ processes under the FRA have been carried out, and they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any, having understood the purpose and details of proposed diversion. Copies of certificates issued by Gram Sabha(s) of Bakrunda & DPF Suranda villages are enclosed as attachment I to V.
- the discussion and decision on such proposals had taken place only when there was a quorum of minimum 50% of the members of each Gram Sabhas present;
- the diversion of forest land for facilities managed by the Government as required under Section 3(2) of the FRA have been completed and Gram Sabhas have given their consent to it;
- the rights of the Primitive Tribal Groups and Pre-Agricultural Communities, where applicable have been specifically safeguarded as per section 3(1) of the FRA, 2006.

...wide for diversion of forest land for 2 main facilities managed by the Government, as specified in that Section which involve felling of trees, exceeding seventy-five trees per hectare, provided that such diversion of forest land shall be allowed only if:

- (i) The forest land to be diverted for the purposes mentioned in the said sub-section is less than one hectare in each case; and
- (ii) the clearance of such developmental projects shall be subject to the condition that the same is recommended by the Gram Sabha.

Keeping in view the above mentioned facts, the above case for diversion of 0.0485 hectare of forest land in the name of Education department for the construction of Government High School Kandhar has also been approved by the District Level Committee. However, Chairman directed the Addl. District Magistrate to refer the case to the Commissioner, Tribal Development, H.P. for issue necessary direction to the Forest department, Mandi to implement the provision of section 3 (2) of Forest Rights Act, 2006 in letter and spirit

After scrutiny of the documents and detailed discussions, the claim of the following applicants were found to be in order and recommended for admission to the District Level Committee.



As informed by Muhal(s) Bakhrunda/495 & DPF Suranda/498 Gram Sabha(s) no application was received claiming rights in Muhal(s) Bakhrunda & DPF Suranda/498 Forest area.

Further, it was suggested and unanimously approved by the member of the committee that the community rights of the forest dwellers of each of the Muhals as expressed and recorded in Naksha Bartan and Wazib-ul-Arz prepared during revenue settlement and the Forest Settlement report of the Forest Department should be recommended under Section 6(3) of the Act for final approval by the District Level Committee. The enjoyment of Community rights which are overlapping shall continue to be concurrent by respective Muhals and the maps maintained by the Forest department showing existing legal boundaries of reserve forests, protected forests, national Parks and Sanctuaries, as the case may be, shall be considered to be community rights for approval by the District Level Committee.




