Sir,

Whereas the Stage-I approval over 1.81 ha. forest land in addition to the earlier diversion over 23.581 ha. of forest land in respect of Patabeda Iron Ore Mines of M/s M.G.M. Minerals Ltd. has been granted by the MoEF & CC, ERO, Bhubaneswar vide Letter under reference (1).

And whereas the Lessee has already deposited ₹1,62,35,630/- towards NPV of 27.086 ha. of entire forest land (₹1,36,76,980/- @ ₹5,80,000/- over 23.581 ha. of diverted forest land, and ₹25,58,650/- @ ₹7,30,000/- over 3.505 ha. of un-diverted forest land).

And whereas on Site Inspection by undersigned, the canopy density over 1.81 ha. of forest land proposed to be diverted vide the above said proposal has assessed as 0.5, Eco-Value Class-I, the NPV need to be charged @ ₹9,39,000/- per hectare over the applied forest area of 1.81 ha. for diversion, i.e. 1.81 ha. x ₹9,39,000/- = ₹16,99,590/-

And whereas out of the above assessed amount you have deposited ₹13,21,300/- @ ₹7,30,000/- per hectare over the said area of 1.81 ha.

Now therefore, the undersigned, by virtue of authority vested by the Apex Court, hereby demand for payment of ₹3,78,290/- (₹16,99,590/- (-) ₹13,21,300/-) towards differential NPV over 1.81 ha. of forest land within 30 days of issue of this Order.

The NPV of ₹ 3,78,290/- (Rupees Three Lakhs Seventy Eight Thousand Two Hundred Ninety only) is to be deposited through e-portal of MoEF & CC as provided in the <http://parivesh.nic.in>, and submit the original proof with seal and signature of the issuing Bank to this office for needful.

It is further ordered that in the event of upward revision of NPV, an undertaking to pay the differential amount is to be submitted by the Lessee.

Accordingly, you are requested to deposit ₹ 9,39,000/- (₹ 9,39,000/- (X) 0.50 ha. (X) 2 times) (Rupees Nine Lakh Thirty Nine Thousand) only towards the above said penalty through e-portal of MoEF & CC as provided in the <http://parivesh.nic.in>, and submit the original proof with seal and signature of the issuing Bank to this office for needful.
