## Demand Notice under FCA 1980

- Legal status of forest land shall remain unchanged.
- 2) The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost as per the directions of Divisional Forest Officer before Stage-II approval.
- 3) The State Government shall charge the Net Present Value of the diverted forest land 0f 0.4858 ha. from User Agency as per the orders of the Hon'ble Supreme Court dated 28-03-2008 and 09-05-2008 in IA Nos. 826 in 566 with related IA's in Writ Petition (Civil) No:202/1995. Accordingly you are informed to pay Rs 506690.00 towards Net Present Value amount.
- 4) Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from user agency. User agency shall furnish an undertaking to this effect

- All the funds received from the user agency under the project shall be 5) transferred/deposited to CAMPA fund only through (https//parivesh.nic.in/)
- Felling of trees shall not be done in the area. 6)
- The user agency shall furnish an undertaking to the effect that they will 7) vacate the diverted forest area by 03-01-2023.
- The forest land shall be reverted back to the State Forest Department after the 8) completion of the lease period.
- The layout plan for the proposal shall not be changed without prior approval 9) of Central Government.
- 10) The forest area shall be used for the purpose for which it is granted. The total forest area utilized for the project shall not exceed 0.4858 ha.
- The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Government of India.
- 12) The compliance report shall be uploaded on e-portal (https//parivesh.nic.in/)
- 13) Any other condition that the Additional Director General of Forests (Central), Regional Office, Bangalore may impose from time to time for protection, improvement of flora and fauna in the forest area and public convenience, shall also be applicable.
- 14) Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF & CC guideline F.No.11-42/2017-FC dated 29-01-2018.

Procedure payment: This Demand Notice is to be uploaded on FC web portal (www.parivesh.nic.in) for acceptance by the Nodal Officer. After acceptance by the Nodal Officer, a challan should be generated from the web portal for payment to the account mentioned in the challan. The Transaction details should be quoted by the User Agency in the condition-wise 'Compliance Report' submitted for Stage-II approval. Payment made by any mode than that mentioned above will not be considered as compliance.
