With reference to the subject cited above, it is submitted that vide reference 3rd cited the Principal Chief Conservator of Forests, (HoFF) Telangana, Hyderabad has communicated in-principle (Stage – I) approval for diversion of the subject project and requested to submit the demand for vetting of the Nodal Officer (FCA).

Out of **1.989** Ha of forest land proposed for diversion in erstwhile Warangal (North) Division, 1.989 Ha of Forest Land falls under the jurisdiction of Tadvai Division. Forest land is detailed below:
