The Sub Collector, Madanpalli has further reported that, the lands in S.No.105/2 measuring an extent of Acs.5.82 cents is quite suitable for compensatory afforestation and no DKT pattas were issued to any body so far in the proposed lands and the lands are free from encroachments; that the forest authorities have inspected the lands and agreed to take the lands for improvements for "Formation of Reservoir across Gangamma Sirassu Vanka near Nalagampalle village to Palamaner Mandal for compensatory afforestation.





In obedaince to the reference 1st and 6th cited above, I submit that I have been instructed the Deputy Range Officer, V. Kota to re inspecte the area and submit detailed report in this regard and showing the same in the surveyed Map. Accordingly, the Deputy Range Officer, V.Kota has submitted a report, reported that he has inspected the proposed Diversion of land i.e., Sy.No. 105/2 of Kaigal revenue village of Bairddipalli (M) an extent of 7.163 Acres (Treatment 5.82 Acres), it is adjoining to the Compartment No: 247, Thotakanuma Reserve Forest of Palamaner Range for formation of Reservoir across Ganganna Sirassu Vanka near Nalagampalli (V), Palamaner (M) in Chittoor District along with concerned staff.
