I herewith re-submit the proposal for Forest land diversion for Road work "Providing BT on Road from Anjani thanda to Pocharam thanda via Shivpur Talab tanda of Peddakodapghal Mandal Jukkal Assembly Constituency of Kamareddy District" sanctioned at Est Cost of Rs 320.00 Lakhs under STSDF(2017-18) grant duly attending the short comings pointed in the reference 6<sup>th</sup> cited.

The total length of the road is 5.30km starting from Anjani tanda connecting to Pocharam thanda reach from 1/6 to 2/4+661 km which falls under forest jurisdiction where already WBM road with 6.0 m width exists. A total length of 0.8661 km with 7.50m width is required to the extent of 0.6496Ha.
