In which request for to arrange to identify the Forest Area (if any) in subject land and issue certificate that "**No alternate Revenue or Private Land is suitable in lieu of the Indented Forest Land**" along with confirmation of "**Availability of equivalent State Land in lieu of the Forest Land proposed for Diversion**" has also been made. Now the Revenue paper for the area falls in the jurisdictions of District Reasi has been received it is seen that from RD 6/900 to RD 5/475 i.e. 1425 mtr falls in village sawalakote, Tehsil, Arnas, District Reasi, is Forest area.




On above subject and reference, this office has placed Land Indent for construction of proposed approach Road from T14P1 to Adit T14 for a length of approximately 04 km alongwith dumping yards 3 nos at RD 4/525, RD 7/775 and RD 10/725 on Katra -Dhrama Section of USBRL Project. After the joint ground verification on dated 04/05/12/2019 with Revenue officials of District Reasi. It has come to the notice that some part of the land in the indent also falls in the jurisdiction of District Ramban i.e. From RD 5/475 to RD 2/975 i.e. 2500 mtr falls in village .Ind, Teh. Gool, District Ramban and pertains to the Forest Deptt. The subject land is urgently required in connection with USBRL Project. The land indent has already been approved by Chief Engineer/South/USBRL/NR. Hence, the proceeding for acquisition of the same may be started immediately.

You are therefore, requested to issue **Forest Right Act (FRA) certificate and Minimum Demand of Forest Land certificate** for Forest land coming between RD 5/475 to RD 2/975 i.e. length 2500 x breath 20 mtr.=50000 sqm + area of Dumping yard at (RD 4/525)= 120X80=.9600 sqm total= 59600 sqm in District Ramban. On receipt of this online submission of Forest Clearance proposal will be done.
