In compliance of the ministry of environment and Forests (MOEF), government of India's letter No. 11-9/98/-FC (Pt.) dated 3rd August 2009 where in the MOEF issued guidelines on submission of evidence for having initiated and completed the process of settlement of right under scheduled tribes and other traditional forest dwellers (Recognition of forest right) Act., 2006 ('FRA' for short) on the forest land proposed to be diverted in favour of Principal Central School Pokhrah Khurd Sadar Medininagar in Jurisdiction of Village Pokhrah Khurd, Block- Sadar Medininagar, District- Palamu details is below .

It is further certified that :

- (a) The complete process for identification and settlement of right under the FRA has been carried out for the entire 10.00 Acre of forest land proposed to be diversion. A copy of records of all consultation and Meeting of the Forest RIGHT Committee (s). Gram Sabha, Sub-Division Level Committee and the District Level Committee are enclosed.
- (b) The proposal for such diversion (with full details of the project and its implication in vernacular/local language) have been placed before each concerned Gram sabha of Forest dwellers, who are eligible under the FRA.
- (c) The each of concerned Gram sabha (s), has certified that all formalities/processes under the FRA have been carried out and that they have been given their consent to the proposed and diversion and the compensation ameliorative measures, if any, having understood the purpose and details of proposed diversion. A copy of certificate issued by the gram sabha of Pokhrah Khurd village is enclosed.
- (d) The discussion and decisions on such proposals had taken pace only when there was quorum of minimum 50% of the member of Gram sabha present.
- (e) The diversion of forest land for facilities managed by the Government as required under section,3(2) of the FRA have been completed and the Gram sabhas have given their consent to it.
- (f) The rights of Primitive Tribal Group and Pre-Agricultural Communities, where applicable have been specifically safeguarded as section 3 (1) (e) of the FRA.

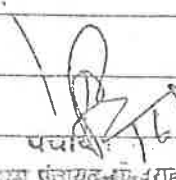
