1. CHAIRMAN

4. OPENING THE TRUST ACCOUNT IN THE NAME OF THE COMPANY

The Chairman informed the Board that as per Reserve Bank of India's guidelines for settlement of gratuity claims (resignation/death/retirement) of employees, the gratuity account is mandatory.
