-Permission for Diversion of 0.1750 ha Protected forest land for construction of Approach road for petrol pump and Complex at village Kondh Taluko – Valia, Dist. Bharuch on Ankleshwar Valia road

Justification for locating the project in forest area to be submitted by user Agency and countersigned by DCF

JUSTIFICATION FOR PROJECT

In consideration of the establishment of Fuel Station/ Petrol Pump to provide diesel and petrol to all type vehicles and Commercial complex. BPCL is satisfied about the prime location of Petrol Pump which is connecting to various nearby villages and authorized M/S Shree Vindheshwari Petroleum for establishing the petrol pump on its plot on Ankleshwar-Valia road which is most suitable location to set up petrol pump/ Fuel station and complex on this plot. This petrol pump will be beneficial to thousands of vehicles including Buses, Four-wheelers and Rickshaws to get the economical Diesel and Petrol at location near to Valia. Consequently, M/S Shree Vindheshwari Petroleum has received the authorization from BPCL for establishing the Petrol Pump and selling of Diesel and Petrol to the Vehicles passing through Kondh Village, Valia Taluka, District-Bharuch . This will indirectly curb the air pollution drastically in this area and the people have not go to long distance to get the Diesel & Petrol.

Base on the Survey Petrol Pump on Ankleshwar-Valia Road, the proposal Petrol Pump and Complex is most Suitable on Ankleshwar-Valia Road, Taluka- Valia.

This Petrol Pump location is finalized as Ankleshwar-Valia Road is the State R&B Road connecting to Various roads of nearby villages and therefore; it is suitable location for setting up of Petrol pump and complex. This location along SH-13 (Ankleshwar-Valia Road) is most technically, environmentally and suitable for Petrol pump and complex.

The Approach Road to proposed Petrol Pump will be constructed which will be passing through Protected Forest land for about 1750 Sq.mtr i.e. Hectores **0.175** of land as per enclosed **Annexure-7**.

Factors considered

While identifying the various alternatives for selection of the proposed petrol pump on Ankleshwar-Valia Road following factors were considered.

- The location of the proposed Fuel Station and complex has been finalized in such a way that minimum forest land will be utilized.
- Demand and supply centre.
- Compliance with environmental regulations.
- Safety of people and property
- Shortest construction of Approach Road to Petrol Pump and complex.
- Avoidance of mining protected and reserved forest archaeological and other sensitive areas.
- Avoidance of unstable ground features.
- Minimizing Road, Rail, Rivers and flood prone areas.
- Avoidance of rocky stretches.
