We wish to bring the following facts for your kind consideration :-

Ours is a Plantation Company engaged in growing Horticultural Crops for the last 20 years in about 100 Acres of land in Survey Nos. 61, 63, 63/1, 64, 68 & 69 Situated at Somajipally Village of Bommaramam Mandal, Nalgonda District which is adjacent to Moodu Chintalapally RF in Ranga Reddy district.

We have been exporting the products there by contributing to our Country's Export Earnings for the last 15 years.

Apart from the exports, we are planning for Poly House cultivation which yields Heavy production, therefore, it has become necessary to use heavy Trucks for loading into the Containers for Shipping purposes.

For the last 2 decades , we and the Neighbouring Farmers have been using the existing way which is 15 mtrs width and a length of 261.8 mtrs under inevitable conditions as our lands have been surrounded by the following :-

1. North : Neighbours' Lands
2. West : Forest & Neighbour's Land
3. East : Neighbours' Lands
4. South : Forest area & Lake. Existing Earthen road of 261.8 mtrs is being used which is connected to the Main BT Road

As there is no other means of passage to enter into our fields, we request you to kindly allot us the existing way which is also getting connected to the Panchayat Raj Earthen Road.

The proposed allotment of land is of 15 mtrs width and 261.8 mtrs length which comes to 0.3927 Ha and the same will be compensated with our adjacent land of 0.4605 Ha .

We, further, undertake that the allotted land will be strongly fenced to have no disturbance/Harm to the plantation done by the TSFDC/HUDA.

We also undertake to grow greenery along both the sides and will bear all the costs whatsoever proposed by the department.

Your positive action in this regard will be highly helpful to our organization in growing & transporting/exporting the agri products.
