A Gram Sabha is conducted today on 28<sup>th</sup> date June day in village Kanesara under the Chairmanship of Shrimati Geetaben Bhanjibhai Malakiya Sarpanch, village. More than 75 % members of Gram Sabha were present in the meeting and the following issues were discussed in the Gram Sabha Meeting.

1. In Kanesara village, Executive Engineer, Rajkot Irrigation Project Division, Rajkot. Has applied for diversion of forest land measuring 09.53.44 Ha. For non-forest purpose i.e. Kanesara-2 M.I. Scheme, which was thoroughly discussed in the meeting.
2. The aim, objectives and use of the said diversion proposal was discussed thoroughly in the Gram Sabha Meeting.
3. The Rules and Regulations of the Scheduled Tribe and the other traditional Forest dwellers (Recognition of Forest Rights) Act, 2006 were discussed keeping in view the said forest diversion proposal. The forest lands proposed for diversion is coming within the Kanesara-2 M.I. Scheme, Executive Engineer, Rajkot Irrigation Project Division, Rajkot. No scheduled Tribe and the other traditional Forest dwellers, are cultivating, residing and doing other traditional activities within the proposed forest land and no Forest Right (individual or community) has been granted to any Scheduled Tribes and the other traditional Forest dwellers within the forest land proposed for diversion.

Hence it was unanimously resolved in the Gram Sabha for proposed diversion of 09.53.44 Ha forest land for non-forest purpose Kanesara-2 M.I. Scheme, in favour of Executive Engineer, Rajkot Irrigation Project Division, Rajkot.

IN COMPLIANCE OF THE MINISTRY OF ENVIRONMENT AND FOREST (MoEF), GOVERNMENT OF INDIA'S LETTER NO. 11-9/98-FC(pt) DATED 3RD AUGUST 2009 WHEREIN THE MoEF ISSUED GUIDLINES ON SUBMISSION OF EVIDENCES FOR HAVING INITIATED AND COMPLETED THE PROCESS OF SETTLEMENT OF RIGHTS UNDER THE SCHEDULED TRIBES & OTHER TRADITIONAL FOREST DWELLERS (RECOGNITION OF FOREST RIGHT) ACT, 2006(FRA) ON THE FOREST LAND PROPOSED TO BE DIVERTED FOR NON-FOREST PURPOSE IT IS CERTIFY THAT 09-53-44 HECTARE OF FOREST PROPOSED TO BE DIVERTED IN FAVOUR OF EXECUTIVE ENGINEER, RAJKOT IRRIGATION PROJECT DIVISION, RAJKOT FOR IRRIGATION PROJECT IN RAJKOT DISTRICT FALLS WITHIN JURISDICTION OF KNESARA IN JASDAN TEHSIL.

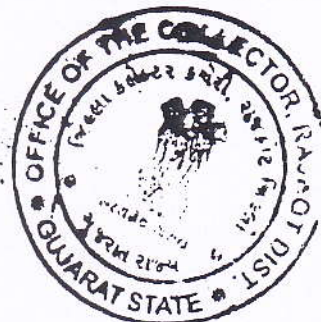
It is further certified that:

1. The complete process for identification and settlement of right under FRA has been carried out for the entire 09-53-44 Hectare of forest land proposed for diversion. A copy of record all consultation and meeting of forest Rights committee, Gram sabha, sub-Division level Committee and District level committee are enclosed.
2. The proposal for such diversion (with full details of the project and its implications, in vernacular/local language) have been placed before each concerned Gram sabha of forest dwellers, who are eligible under the FRA.
3. The each of concerned Gram sabha has certified that all formalities/processes under the FRA have been carried out, and that they have given their consent to the proposed diversion and the compensation and ameliorative measure, if any, having understood the propose and detail of proposed diversion. A copy of certificate issued by the gram sabha of KNESARA is enclose.
4. The discussion and decision on such proposals had taken pace only when there was a quorum of minimum 50% of the member of gram sabha present.
5. The diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA Have been completed and the gram sabha have given their consent to it.
6. The right of Primitive Tribble Groups and Pre-Agricultural Communities, where applicable have been specifically safeguarded as per section 3(1)(e) of the FRA.
