- (c) The proposal does not involve recognized right of primitive and pre-agricultural Communities.



A copy of certificate issued by the gram sabha of Chikatbarri village(s) is enclosed as annexureto annexure
- the discussion and decisions on such proposals had taken pace only when there was a quorum of minimum 50% of the members of Gram Sabha present;
- the diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Gram Sabhas have given their consent to it;
- the rights of Primitive Tribal Groups and Pre-Agricultural Communities, where applicable have been specifically safeguarded as per section 3 (1) (e) of the FRA.
