1. Project details:

- (i) Short narrative of the proposal and project/scheme for which the forest land is required:-
The scheme is for construction of 33 kv line to connect newly constructed 33/11 kv power sub-station at Jamuwawan under DDUGJY scheme. The proposed 33 kv line to connect Jamuwawan sub-station from Musahari 33/11 kv sub-station. The line transverses through Mushari to Jamuwawan under Nalanda district of Bihar. This sub-station cover 100 village. The line enroute will go along Biharsharif-Ekangarsarai-Telhara road which are notified forest area in Nalanda forest division, where a corridor of 3.5 mtr. will be utilized for construction of the line as well as maintaining electrical clearance during operation.
- (ii) Map showing the required forest land, boundary of adjoining forest on a 1:50,000 scale map: Enclosed Annexure-1
- (iii) Cost of the project: Rs. 164.88 crore (Approx.)
- (iv) Justification for locating the project in forest area: Only social forest across the State/National highways is being crossed by the said line.
- (v) Cost- benefit analysis: N/A
- (vi) Employment likely to be generated: There will be rural development in the State especially in the district of Nalanda on implementation of this project. This will create large opportunity of jobs and employment. More than 500 manpower engaged to construct sub-station as well as line.

2. Purpose- wise break-up of the total land required: 15 mtr.x 600 mtr= 9000 sq. mtr. Or 0.9 ha

- (iii) Rehabilitation plan (to be enclosed): Not required.


