Subject: Diversion of 0.00835 ha. of forest land for access to retail Outlet of IOC Ltd. along Sultanpur - Dhottar Road at Village Sultanpuria, under Division & Distt. Sirsa. Haryana .

Sir/Madam,

Kindly refer to the subject cited above mentioned proposal, in which the permission of the State Government has been sought under Van (Sanrakshan Evam Samvardhan) Adhiniyam. 1980. In this regard, in Principle approval was granted by this officer dated 13.12.2021, Whose compliance report was received from Divisional Forest officer Sirsa vide letter dated 24.06.2024 In accordance with power delegated to Nodal Officer (FCA) by Govt. of Haryana vide order no.629-Ft-1-2024/1749 dated.15/03/2024 for diversion cases less than 0.1ha., **Final Approval** for the above-mentioned project is hereby granted subject to the following conditions:-

1. General Conditions

S. No	Conditions
1.1	1. Legal status of the forest land shall remain unchanged. 2. The number of trees/plants to be felled shall not in any way exceed the number indicated in the proposal and no harm shall be done to the wildlife during felling of trees. The felling of trees/plants will be carried out under the strict supervision of the State Forest Department and the amount spent on felling of trees/plants will be deposited by the user agency to the State Forest Department. 3. As per the proposed CA Scheme, Compensatory Afforestation (CA) shall be taken up by the State Forest Department over degraded forest land in Kalanwali Range, Tehsil Kalanwali, Distt. Sirsa by planting 100 plants at the cost of the user agency. The Plantation shall be done within one year from the date of issue of approval. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species shall strictly be avoided. 4. The compensatory plantation should be done within one year from the date of issue of this letter. 5. The Divisional Forest Officer shall upload the KML files of the degraded forest area accepted for raising compensatory afforestation in the E-Green watch portal of FSI,

	before handing over of forest land to the user agency. - The initial permission is given to this proposal for 99 years. After that the permission shall again be obtained from the Competent Authority. - The forest land shall not be used for any purpose other than that specified in the proposal. - The user agency shall pay additional amount of NPV as and when increased by the order of Hon'ble Supreme Court and the Divisional Forest Officer will ensure that the increased amount is deposited. - No damage will be done to the adjoining forest land. Simultaneously, all efforts will be made to save adjoining forest and forest land. - The forest land proposed to be diverted shall, under no circumstances, be transferred to any other agency, department, or person without approval of the Competent Authority. - No labor camp of any kind will be set up on forest land. - The layout plan of the proposal shall not be changed without prior approval of Competent Authority under Van (Sanrakshan & Samvardhan) Adhiniyam, 1980. - The user agency shall carry out muck disposal at pre-designated sites as per the scheme approved. - User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable. - Any other condition may be stipulated by Divisional Forest Officer from time to time, in the interest of conservation, protection and development of forests & wildlife. - It will be the responsibility of the Divisional Forest Officer /User Agency to obtain all other prior approvals/clearances under all other relevant Acts/Rules/ Court's Rulings/instructions, etc., including environmental clearance, as applicable to this proposal. - Violation of any of these conditions will amount to violation of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and action would be taken as per the MoEF&CC, consolidated guidelines and clarifications on Van (Sanraksh

2. Standard conditions

S. No	Conditions
2.1	- Light Crown trees should be planted at an interval of 1.0 to 1.5 meters on the entire periphery of the station leaving 1.5 meters space from the wall. - The user agency will also carry out plantation on the access road (Entry/Exit Or Deceleration/Acceleration) and on the Separator Island and this separator island will not be used for any kind of commercial purpose.

3. Specific conditions

S. No	Conditions
2.1	The Competent Authority may suspend/cancel this approval if the implementation of any of the above conditions is not satisfactory. The Divisional Forest Officer will ensure compliance of these conditions.
