MEMORANDUM:-

This department has given an "In principle" approval for Diversion of **0.11108 ha**. Protected Forest land for laying of 8'dia steel Gas Pipeline Connectivity for Bilasiya Bus Stand to Kanubhai Rabari CNG Station, Ta. Daskroi, Dist. Ahemdabad in favour of Manager Steel Project and ROU/ ROW, Sabarmati Gas Limited vide letter referred at Sr. No.(1) above.

The Nodal Officer (FCA), Gujarat has reported in his letter referred at Sr.No.(2) above that the User Agency has deposited an amount Rs.75,299/-towards the cost of Compensatory Afforestation & Erection of pillars and Rs.95,614/- towards the cost of NPV in the CAMPA fund on 03.07.2024. Moreover, User agency has fulfilled all the conditions mentioned in the "in principle" approval of this department letter referred at Sr. No.(1) above.

In view above, the undersigned is pleased to convey the formal approval of the Government of Gujarat under section 2 of the Forest (Conservation) Act, 1980, subject to the following conditions:-

1. This permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
2. The forest land shall not be used for any purpose other than that specified in the FCA proposal.
3. Compensatory afforestation is proposed for 100 tree plantation at Survey No.100 pt., Village- Navagam karna, Ta. Dholera, Dist. Ahmedabad at the cost of Rs.72,399/-.
4. User Agency will have to obtain permission from the Nodal Officer (FCA), for carrying out any maintenance works in future.
5. User Agency will have to restore the forest land after use/ maintenance work.
6. User Agency will be liable to compensate any loss to Forests / Environment caused due to the use of the said land by the user agency.
7. User agency will seek permission from the Roads & Buildings Department/Science and Technology Department, Sachivalaya, Gandhinagar, if required so.
8. Any other condition, which the Nodal officer (FCA) and State Government may stipulate from time to time.
