JUSTIFICATION FOR LOCATING THE PROJECT IN FOREST AREA

Shree Nakoda Bhairav Darshan Dham is established purely for following philanthropic purposes on "no profit no loss" basis:

- 1) to assist, encourage, promote and extend financial and other support and assistance to school, collages, universities, libraries, educational institutions, hostel for public at large on non profit basis.
- 2) to provide medical treatment to needy persons without any distinction of sex, caste, creed, place and religion.
- 3) to administer, assist, encourage, promote and extend financial and other support and assistance to clinic, dispensary, hospital etc. for public at large on no profit basis.
- 4) to provide assistance of shelter house, orphanage, convalescence home and the like for the welfare and benefit to the old, distressed, needy, afflicted, diseased, destitute, handicapped, widows, orphans, infirm or indigent persons.
- 5) to provide food, meals, boarding, lodging, clothing, education, medical and financial aid or other assistance, necessities, comforts or amenities to the old, distressed, needy, afflicted, diseased, destitute, handicapped, widows, orphans, infirm or indigent persons.
- 6) to provide relief in the event of natural calamities such as earthquakes, fires, flood, draught, riots, civil commotions or otherwise.

To facilitate these activities of philanthropic service to society, trust purchased 31-77-17 ha. of private land in survey numbers 65,66,67,68,69 of Dhekale Village and propose to construct various structures such as school, hostel, hospital, dispensary, lodging & boarding facilities.

There was cart road available from main High Way through forest area. Since while constructing the road, National Highway Authority raised the height of road making the existing road in-accessible. So there is necessity of raising level of existing cart road and construct road to connect to National Highway.

There is no access/approach from existing road to reach private survey numbers 65,66,67,68 & 69 of the Project Authority unless to cross the protected forest survey No.101 & W34. Private Survey Numbers 65,66,67,68 & 69 are surrounding by one side(northen side) by private survey numbers owned by other private parties who have developed those properties as such obstructing access to the private property of the Project Authority. Other three sides are surrounded by forest. Out of these three sides, except for one side, i.e. western, other two sides have thick forest and area is highly undulating. Only area covering survey No. 101 & W34 has no tree cover and requires minimum area of forest. It is shortest way to reach National Highway 8.

Therefore there is no access/approach from existing road to reach own private survey numbers unless to cross the protected forest survey no. 101 & W34 which is most suitable, minimum and feasible alignment given as per actual ground position. Secondly proposed alignment of present road is especially more convenient and easily accessible for accident victims and also students and people in general.
