Further the The Superintending Engineer, TDWSP (RWS&S) Circle, Nirmal is requested to furnish the **copies of Paper clippings about the publishing of forest Clearance etc.,** as instructed by the Prl. Chief Conservator of Forests TS Hyderabad vide reference 2<sup>nd</sup> cited the said reference along with its enclosures are enclosed for their ready reference.

**The user agency is requested to upload the demand notice at forestsclearance.nic.in and generate challan through the Ministry's Website, after approval by Nodal officer and then deposit the above amounts against the challan generated. Step-by-step process for depositing the funds is available at forestsclearance.nic.in.**

Further it is also informed that, this in-principle approval shall be valid for a period of 5 years. In the event of non-compliance of the above conditions, this in-principle approval shall automatically stand revoked after 5 years.

But the User Agency has not submitting the condition wise compliance report on (Stage-I) approval is till-to-date.

Therefore, the Superintending Engineer, Telangana Drinking Water Supply Project, (RWS&S) Circle, Nirmal is once again requested to submit the condition wise compliance report on **(Stage-I)** approval along with remittance particulars of demand notice and furnish the required information/ connected documents as called in this case urgently for taking further course of action.

It is submitted that, Principal Chief Conservator of Forests (Wildlife) & Chief Wildlife Warden, Telangana Hyderabad vide reference cited 5<sup>th</sup> cited has requested to furnish the length of the pipeline passing through the segment in wildlife area and indicate the unit cost per KM for planting of the low height evergreen shrubs as per the existing FSR and project report should be prepared for taking up such activities duly implementing financial & physical achievements.

In compliance to the instructions issued in the reference 6<sup>th</sup> cited above, it is submitted that, the Forest Divisional Officer, Asifabad vide reference 7<sup>th</sup> cited has stated that the length of pipeline is **14830.71 Mtrs** in **Segment-22/15 (Dhanora)** is passing through Corridor area of Kawal Tiger Reserve of Kerameri Range in wildlife area out of the total length is **59066.08 Mtrs** in Segment-22/15 (Dhanora) which was furnished in the Part-III and field inspection note along with the wildlife proposals and the revised proposals for falling in the wildlife area i.e., Corridor area of Kawal Tiger Reserve for Planting low height evergreen shrubs with shallow roots on the both sites of the pipeline to shelter to small wild animals shall be taken every (2) meters for planting of low height vegetation on the both sides for the proposed the length of pipeline is **14830.71 Mtrs** in **Segment-22/15 (Dhanora)** is worked out for **Rs.36.950 Lakhs** as per the 42<sup>nd</sup> Minutes of the meeting has recommended in condition no (5) and the unit cost as per the existing FSR 2017-18 for planting is Rs.2.492 Lakhs per KM (including the Raising of nursery, planting and maintenance up to 7<sup>th</sup> year).

In view of the above, it is requested to kindly accord permission to raise the above demand to the user agency.
