- b) The proposal for such diversion (with full details of the project and its implications in vernacular/ local language) have been placed before each concerned gram Sabha of forest Dwellers, who are eligible under the FRA.
- c) The each concerned Gram Sabha(s) has certified that all formalities/process under the FRA have been carried out, and that they have given their consent to the proposed diversion and the compensation and the ameliorative measures, if any having understood the purposed and details of proposed diversion. A copy of certificate issued by the Gram Sabha of Mugalolli Panchayat Sangondi village is enclosed.
- d) The discussion and decisions on such proposals had taken place only when there was a quorum of minimum 50% of the members of Gram Sabha present.
- e) The diversion of forest land for facilities managed by the Government as requires under section 3(2) of the FRA have been completed and the Gram Sabha(S) have given their consent to it.

The rights of the Primitive Tribal Groups and Pre-agricultural communities where applicable have been specifically safeguarded as per Section 3(1) (e) of the FRA.
