With reference to the aforesaid memo on the captioned subject, you are requested to deposit the approved cost of Rs. 122.532 lakh pertaining to this division towards Site Specific Wildlife Conservation Plan which has been approved by the Principal Chief Conservator of Forests (WL) & Chief Wildlife Warden, Odisha vide his memo No.10886 dt.20.12.2019 in the appropriate head of CAMPA within 30 days from the date of issue of this demand notice and communicate the copy of e-challan bearing seal and signature of Bank and UTR number for compliance to stage-I approval.

You may please note the following conditions for further compliance;

1. This plan may be revised after 5 years and the User Agency will give undertaking to contribute towards the revised cost of the conservation plan till the project period, if any.
2. The project proponent has to prepare and submit the conservation plan for next 10 years. If there would be need for Site Specific Wildlife Conservation Plan after expiry of the present plan period, the user agency will have to submit another such plan at least one year before the expiry of the present Conservation Plan and deposit the outlay amount upon its approval. In case of delay, it will be dealt as per law for violation of Forest Conservation Act, 1980 and Environment (Protection) Act.1986.

3. The Project proponent has to give an undertaking to bear the differential cost in case of enhancement of wage rate at the time of implementation of this plan.

It is to inform you that you have to implement a Site Specific Wildlife Conservation Plan for widening and strengthening of existing double lane road to two-lane with 1.5m wide paved shoulder on either side from Km 35/700 to Km 71/120 of NH-220 of Rairangpur to Jashipur section coming within Rairangpur and Karanjia Forest Division within jurisdiction of Mayurbhanj District in the State of Odisha in compliance to the additional condition stipulated by State Government in their letter No.16560/F&E dt 30.07.2018 while forwarding the letter No.5-ORC358/2018-BHU dated 18.07.2018 of ERO, MoEF&CC, Government of India granting Stage-I approval for diversion of 7.8199 ha of forest land for the above purpose.

2. The Site Specific Wildlife Conservation Plan in respect of the above project has been approved by the undersigned with financial forecast of ₹274.344 lakh (Rupees two crore seventy-four lakh thirty-four thousand four hundred) only for the following activities.

3. Various activities in the forest area to be diverted will be executed by the Project proponent under the guidance of the DFO, Karanjia/Rairangpur Division, as the case may be. A sum of ₹245.064 lakh only may be transferred through online portal of CAMPA account of the State for the purpose for implementation of various activities within the project impact area by the Forest Department as envisaged in the plan.

4. You may please note the following conditions for future compliance.



In inviting reference to the letters on the subject cited above, I would like to inform you that, the Government of India, Ministry of Environment Forest & Climate Change, Eastern Regional Office, A/3 Chandrasekharpur, Bhubaneswar have accorded in Principle (Stage-I) approval for diversion of 2.6089 ha. of Forest land of Rairangpur Forest Division vide Letter No.5-ORC358/2018-BHU dt.18.07.2018.

As per item No. (iv) of the approval order Letter No. 5-ORC358/2018 - BHU dt.18.07.2018 and Letter No. 16817/9F (Road)-316/2018 dt.06.08.2018 of the Additional Principal Chief Conservator of Forests, (Forest Diversion and Nodal Officer, F.C. Act) O/o the Principal Chief Conservator of Forests, Odisha, Bhubaneswar, compensatory afforestation is to be raised over 7.819 ha. of non-forest land identified in village Ghodadega of Kusumi Tahasil of Rairangpur Division. The Compensatory Afforestation scheme amounting to Rs.20,06,600/- (Rupees twenty lakhs six thousand six hundred) was prepared & approved by PCCF, Odisha during August 2018 as per old wage rate of Rs. 213.50/-. Now the financial outlay for compensatory afforestation scheme has been revised to Rs.21,96,800/- (Rupees Twenty one lakh ninety six thousand eight hundred) only due to revision of wage rate with minimum wage rate of Rs.303.40/- per manday and the same has been technically approved by PCCF (FD & NO, FC Act). Since you have already paid Rs.20,06,600/- (Rupees twenty lakhs six thousand six hundred) only as per old wage rate of Rs.213.50/-, now therefore you have to pay Rs.1,90,200/- (One lakh ninety thousand two hundred) only towards the differential amount of CA Scheme
