1.	Project Details	:	
i)	Short narrative of the proposals and project scheme for which the forest land is required.	:	<p>For diversion of 1.3217 Ha of Forest land in Zaphi Singampally Reserved Forest of Siddipet Division & District of Medak Circle for formation of approach road Hyderabad to Karimnagar Highway to the agricultural lands situated at Singaipally and Annasagar Villages of Siddipet District and Turkapally Village of Shamipet Mandal of Medchal District in favour of Sri N Sudhakar Reddy and Others.</p> <p>We have approximately more than 100 Acres of agricultural lands owned by more than 30 farmers in Singaipally and Annasagar Villages of Siddipet District and Turkapally Village of Shamirpet Mandal of Medchal District. From the day unknown we are using the existing road cart track passing along the boundary of the Reserve Forest from Hyderabad - Karimnagar High way to reach the said agricultural lands in question.</p> <p>This is the only approach road which was also being used by us to carry out the day to day agricultural activities and also to transport the agricultural products to the nearest High Way and market yard and thus have livelihood for our families. To our knowledge this road is being used for more than 5 decades.</p> <p>Very recently the Forest Department officials have started trench work all along the boundary of Reserve Forest area and also dug a trench on boundary of the forest land, due to which we are unable to carry out our day to day agricultural activities, and for the very reason we have suffered huge loss and also subjected to mental and financial agony and the work force which have been deployed for the said agriculture work have also lost their livelihood and are facing lot of hardship during this pandemic time. Instead of raising any disputes, we proposed to give equivalent land next to the existing forest and seek diversion of forest land for continuing to use it as a public road.</p>


