S.O. WHEREAS it appears to the Central Government that coal is likely to be obtained from the land mentioned in the Schedule hereto annexed;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 4 of the Coal Bearing Areas (Acquisition and Development) Act, 1957 (20 of 1957), the Central Government hereby gives notice of its intention to prospect for coal therein;

The plan of the area covered by this notification may be inspected in the office of the Central Coalfields Limited, Revenue Section, Darbhanga House, Ranchi-834001 (Bihar), or in the office of the Collector, Mirzapur, Uttar Pradesh, or in the office of the Coal Controller, 1-Council House Street, Calcutta-1.

All persons interested in the land covered by this notification shall deliver all maps charts and other documents referred to the sub-section (7) of section 13 of the said Act to the Revenue Officer, Central Coalfields Limited, Darbhanga House, Ranchi-834001 (Bihar) within ninety days from the date of the publication of this notification.
